With the medium of this Appeal to General Public, all Motorists vehicle owners, vehicle operators, drivers of Private/Commercial Vehicles / Transport Unions etc. are hereby informed that in light of the Hon'ble Supreme Court directions notified vide Circular No. **TC/JK/Pg&S/597-99 dated 01.02.2016**, Transport Commissioner J&K notification No. **R/JK/2012/4521-47 dated 24.05.2012** and **TC/JK/MV/2019/3091-318 dated 18.04.2019**, notification issued by MoRTH New Delhi vide No. **RT-II-028-01-2018/MVL dated 01.07.2019** affixing of HSRP (High Security Registration Plate) by or before 16.09.2017 on the motor vehicles has been made mandatory.

Despite of repeated directions from RTO Jammu and Public Notice issued by vide No. **304-08/RTOJ/PA/2021 dated 02.09.2021** as well as continuous enforcement by Traffic Police Jammu , a good number of motor vehicles are still plying without affixing of HSRP (High Security Registration Plates) in contravention to the directions of Apex Court/ MoRTH and Transport Commissioner J&K .

As such general public/concerned owners/drivers plying their motor vehicles without affixing of High Security Registration Plates (HSRP) are advised / reiterated to get their vehicles affixed/ registered with HSR Plate immediately from the authorised Vendor namely **M/S Real Mazon India Ltd J&K (Mr. Ravish Malhotra 9419188484)** assigned with the task by Transport Department J&K .
