JAMMU: Ex-MLA Jammu East and senior Congress leader Yogesh Sawhney on Sunday toured the Padh Village, Sodha Village Ward No. 8 located in Aitham Patwar in Jammu district where he visited the holy shrine of Baba Bhed to seek blessings and later interacted with the residents of the village to discuss their issues.

Various people had gathered to meet with the former Minister and raise some of their grievances. Sawhney called the Chief Engineer,

Jammu to raise his concern and an immediate resolution was provided to the people as water was released to the village.
