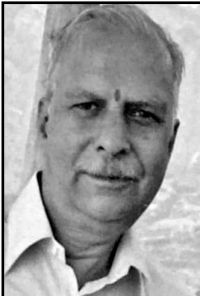

8 houses gutted as devastating fire leaves 24 families homeless in Batamaloo; 10 firemen injured

SRINAGAR: At least eight houses were gutted in a devastating fire in Batamaloo area of Srinagar, officials said on Monday.

In all, 24 families were residing in these houses while atleast 10 firemen got injured in operation. Some fire-fighters were also beaten up by locals as they demanded dousing flames in their respective houses on priority.

As per details, soon after getting information about fire late last night, the fire tenders rushed to Sheikh Hamza Colony Batamaloo.

Eight houses were gutted before firemen brought the

flames under control in congested locality, the official said.

"We made best efforts to contain the fire and prevent it from spreading to other structures as locality is quite congested," they added. At least 10 firefighters were injured with three in critical condition, who were identified as Mohammadd Ahsan Malla, Altaf Ahmad Rather and Akshay Sehgal. Officials said that most of the houses damaged in blaze were three-storey structures and in all, 24 families living in them got affected.

Three poachers arrested in Budgam

BUDGAM: Police arrested three poachers and seized three singl-bore guns and six cartridges from them in Narkarah wetland area of Budgam district on Monday.

As per details, police was informed by Range officer Wildlife Control Room Srinagar about three persons hunting down migratory birds at Nambal, Narkarah, which were identified as Ali Mohammad Najar, Umar Majeed Bhat, and Ishfaq Majeed Bhat, all residents of Nadir Gund Humhama. The police has registered FIR number 65/2022 under Sections 428 of IPC and 51 of wildlife act 3/25 against them.


