The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 be submitted to the Executive Engineer PWD (R&B) Const. Divn. No. II Jammu at the time of allotment.
2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential submission of bids is allowed any number of times. Whereas, the Govt. of India through Ministry of Road Transport & Highway (MoRTH) Vide Notification No. SO 3164 (E) Dated 15.09.2020 under section 3A of National Highway Act, 1956 declared its intention to acquire the land particulars of which mentioned in the schedule along with trees & structures etc for construction of Double Lane Road with paved shoulders on the Existing Double Lane specification Akhnoor-Poonch NH-144A in village Androlla Tehsil & District Rajouri.

Whereas, the said Notification issued under Section 3A of National Highway Act, 1956 was published by Competent Authority Land Acquisition (CALA) in Daily Excelsior newspaper dated: 23.11.2020 for inviting objections from the interested persons within stipulated time frame of 21 days from the date of publication.

Whereas, none of the land owners/ interested persons objected before the Competent Authority Land Acquisition (CALA) within stipulated period of time and accordingly the Govt. of India through Ministry of Road Transport & highway (MoRTH) issued Notification under section 3D of National Highway Act, 1956 vide No SO 1136 (E) dated 10.03.2021 for an area of 0.0275 Hectare declared that land specified is to be acquired for aforesaid purpose.
