Earlier, in the semifinals, decided on Wednesday, Doda defeated district Srinagar by a margin of three points while Udhampur trounced Baramulla by a turn and five points. In a preliminary round match, Srinagar

defeated district Samba by three points.

In total, 20 districts of the Union Territory are taking part in this three-day event being held under the supervision of district (DYSS) officer, Swaran Singh.

No Candidate of less than 13 (+) years of age as on 1st of November and 1st of may Preceding the year in which he/she has to appear in the Secondary School Examination (Class 10th) shall now be eligible for registration in 9th class.
