Government Order No. 37 -JK (PDD) of 2022
Dated: 14-03-2022

Whereas, in order to repatriate Engineers who had completed their tenure from the UT of Ladakh to UT of J&K and to depute equal number of Engineers (Electric) of UT of J&K to UT of Ladakh, a panel of Officers/substitutes was recommended by the Power Development Department to the General Administration Department for further action; and.

Whereas, the General Administration Department, accordingly, repatriated these eight (8) Engineers from UT of Ladakh to UT of J&K vide Government Order No.1369-JK(GAD of 2021 dated 27/12/2021 issued under Endorsement No.GADSERVOGENL/18/2021 dated 27/12/2021 with the directions to officers to report in the Power Development Department for further postings; and

Whereas, consequent upon above, the following Engineers including Mr. Hakim-ud-din and Mr. Mohd Khan, I/C Assistant Engineer of PDD were deputed to UT of Ladakh vide above said Government Order with the stipulation that they shall be deemed to have been relieved from their respective places of posting with further directions to report in the General Administration Department, UT of Ladakh for further posting:-

Whereas, instead of joining their duties at the new place of posting, Mr. Hakim-ud-din and Mr. Mohd Khan I/C AE, JKPCD (now working at TLMD-1, Srinagar and STD , Kalakote respectively) by feeling aggrieved of the said transfer/posting order have knocked the doors of Central Administrative Tribunal (CAT) Bench, Srinagar for seeking quashment/reconsideration of their transfer to UT of Ladakh through O.A No.17/2022 and the CAT has passed the following directions in the case;

Respondents are directed to consider the representation of the applicants within two weeks in accordance with Law and communicate the decision to the applicant. Till then respondents shall not give effect to the transfer order.

Whereas, the Administrative Department (PDD) while taking into consideration the fact that transfer and posting of the above mentioned Engineers has been formally been effected by the General Administration Department purely in the interest of Administration and accordingly, felt that non-compliance of the said Government Order by these Engineers regarding their transfer to the UT of Ladakh is in itself a clear violation of the instructions of the Government which involve/warrant departmental action; and

Whereas, for efficient cadre management, a member of a service or class of a service may be required to serve in any part of the areas of jurisdiction in any post borne on the cadre of such service or class and all transfers and postings shall be made by the authority prescribed by the Government in this behalf; and

Whereas, transfer orders are passed in the exigencies of service and transfers are part of the service of every employee and it is the prerogative of the employer to see at what place the service of an employee can be utilized properly in the larger public interest and an employee holding a transferable post has no right to insist that he should be allowed to continue to serve at a particular place or on a particular post.

Now therefore, consequent upon the above, claim of these applicants/Engineers namely Mr. Hakim-ud-din and Mr. Mohd Khan I/C AE, JKPCD (now working at TLMD-1, Srinagar and STD , Kalakote respectively) for quashment/reconsideration in terms of orders of Hon'ble CAT for their transfer to UT of Ladakh, lacks any cogent merit as the same is against the spirit of prevalent rules and regulations and accordingly rejected.

It is further ordered that the concerned Managing Directors shall deliver the Govt. Order to the concerned officers/employees within 2 days and relieve these officers from their present places of posting forthwith. In case, the officers do not join at their new place of posting, the concerned DDOs shall not draw their salary henceforth and a report to this effect shall be submitted to the Administrative Department by or before 20/03/2022 for placing the officers under suspension.
