CRIME REPORT

Drug peddler arrested, contraband recovered

GANDERBAL: To eradicate the menace of drugs, Police on Saturday arrested a drug peddler in Ganderbal and recovered contraband substance from his possession.

As per details, officers from Police Post Shadipora at a checkpoint established at Sheikzoo near river Jehlum intercepted a suspect identified as Mubarak Shafi Reshi, son of Mohd Shafi, resident of Sheikhzoo. During checking, 70 gm contraband substance was recovered from his possession. He was arrested and shifted to police station where he remained in custody. Accordingly, FIR No. 62/2022 under relevant sections of law was registered at Police Station Ganderbal and investigation started.

MVD team books scores of vehicles for overcharging, other violations

REASI: On directions of Deputy Commissioner Reasi, ARTO Reasi on Saturday conducted extensive checking at different places in Katra and compounded scores of passenger vehicles for overcharging of fare. Based on a number of complaints received regarding overcharging from pilgrims, ARTO Reasi Rajesh Gupta conducted on spot checking in and around Katra town, during which the team challaned 58 Vehicles for overcharging & other violations besides imposing a fine of Rs 2.0 lakh. 41 other vehicles were compounded and fine amounting to Rs 41,000 was recovered on the spot. Five vehicles including 3 motor-cycles and two autos were also seized.

The ARTO asked Rickshaw operators to display fare list for convenience of general public & especially for pilgrims. The ARTO also sensitised drivers about Motor vehicle Act and urged them to follow the same for their as well as others' safety.

Theft case worked out; 2 arrested, stolen property recovered

UDHAMPUR: Police on Saturday worked out a theft case by arresting two accused and recovered stolen property.

As per details, based on written complaint from one Vipan Sharma, son of Munshi Ram, resident of Ward-1, Udhampur regarding theft/ burglary, FIR No 96/2022 under sections 457/380 of IPC was registered at Police Station Udhampur. Subsequently, a team led by SHO Udhampur Chaman Gorka under the supervision of Dyasp Hqrs Udhampur Sahil Mahajan conducted raids at different suspected locations, during which some suspects were zeroed-in by police. During sustained questioning, one of the suspects broke down and confessed his crime and was arrested.

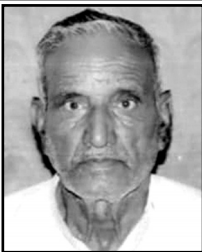

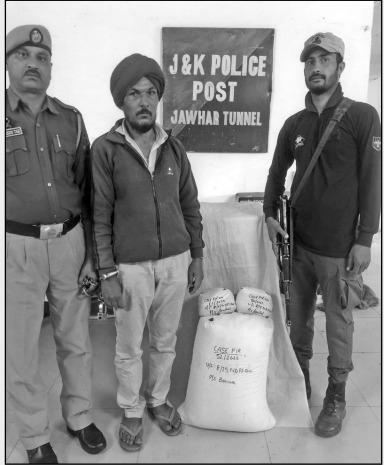
