Indian student killed...

Singh Puri and Kiren Rijiju left for Hungary and Slovakia respectively, a day after the government decided to send four Union ministers as India's special envoys to neighbouring countries of Ukraine to oversee the evacuation of Indians from the war-torn country through its border crossings.

The other ministers who will oversee the evacuation process are-V K Singh and Jyotiraditya Scindia. Singh had left on Monday night for Poland.

The MEA said Foreign Secretary is calling in ambassadors of Russia and Ukraine to reiterate its demand for "urgent safe passage" to Indian nationals who are still in Kharkiv and in other cities in the conflict zones.

"Similar action is also being undertaken by our ambassadors in Russia and Ukraine," the MEA said.

They said India has already taken up with the Russian and Ukrainian embassies the "pressing" requirement of safe passage to Indian nationals, including students, from Kharkiv and other cities in conflict zones.

"This demand has been repeatedly made to Russia and Ukraine since the beginning of this conflict on February 24. It has been conveyed to both their ambassadors in New Delhi as well as taken up in their capitals," said a source.

"An Indian team has been positioned in the Russian city of Belgorod, close to the Ukrainian border. However, the conflict situation in and around Kharkiv and nearby cities has been an obstacle," the source said.

"Therefore, it is imperative that Russia and Ukraine respond to our need for safe passage urgently," it said

The sources said in places where the conflict has not endangered movement, Indian authorities have been able to evacuate the citizens. They said India will continue to make utmost efforts to ensure the return of Indian citizens stranded in Ukraine.

On evacuation front, three evacuation flights from Romania's capital Bucharest and Hungary's capital Budapest came to India on Tuesday with 616 Indian nationals who were stranded in Ukraine due to the Russian military offensive, officials said.

On Tuesday, two flights were operated by IndiGo while one service was operated by Tata Group-owned Air India Express.

India began the evacuation of its citizens from Ukraine's western neighbours such as Romania and Hungary on February 26. Private Indian carriers have brought back 2,012 Indian nationals in nine special flights till now.

Air India Express operated the Bucharest-Mumbai flight via Kuwait with 182 Indian nationals.

IndiGo operated Budapest-Delhi flight via Istanbul with 216 Indian nationals.

India's largest carrier also operated Bucharest-Delhi service via Istanbul with 218 Indian nationals.

Meanwhile, IndiGo sent four planes, two to Budapest and two to Rzeszow in Poland, to evacuate Indians. SpiceJet also sent a plane to Kosice in Slovakia for evacuation on Tuesday.

Civil Aviation Minister Jyotiraditya Scindia had said on February 27 that around 13,000 Indians, mainly college students, are currently stranded in Ukraine.

Ukrainian airspace has been shut down since February 24, when the Russian government started its military operations against the country.

In first Indian casualty in the war in Ukraine, a student from Karnataka was killed in shelling in Kharkiv city on Tuesday morning.

External Affairs Ministry confirmed the death of the Indian in a tweet.

Prime Minister Narendra Modi has asked the Indian Air Force (IAF) to evacuate Indians stranded in Ukraine due to the Russian military offensive against that country, sources said on Tuesday.

Indians are travelling by road to Ukraine's borders with Romania, Hungary, Slovakia, Poland etc, from where they are being taken by the Indian government officials to airports for evacuation flights.

The Indian Embassy in Ukraine on Twitter advised all Indian nationals, including students, to leave Kyiv urgently on Tuesday itself, preferably by available trains or through any other means available.

Indus Water Treaty...

for Indus Waters under obligations of the Indus Water Treaty-1960. India and Pakistan signed the treaty in 1960 after nine years of negotiations, with the Washington-based World Bank being a signatory. The treaty sets out a mechanism for cooperation and information exchange

between the two countries regarding their use of the rivers. However, there have been disagreements and differences between India and Pakistan over the treaty.

The Indian delegation's visit was earlier scheduled for mid-January, but it was postponed at the request of India due to COVID-related restrictions. The meeting is taking place amid the chill in bilateral relations over the Kashmir issue.

The Indian delegation includes three female officers. This is the first time since the signing of the treaty that three female officers are part of the Indian delegation.

The delegation comprises Saxena's advisors from the Central Water Commission, the Central Electricity Authority, the National Hydroelectric Power Corporation and the Ministry of External Affairs.

A Pakistani official said the participants are set to discuss arrangements regarding communication of advance information about flood flows during the current season, maintenance of free flow of water into Sutlej river and finalisation of future programmes, meetings and tours and inspections.

The participants, under the agenda items of the meeting, will also finalise and sign a record of the last PCIW meeting.

"There is no plan for any field visit/inspection by the Indian delegation members during their stay in Pakistan as they have come to participate in the meeting only, the Pakistani official said.

Besides objections already under discussions over 1,000MW Pakal Dul and 48MW Lower Kalnai hydropower projects, Pakistan has also expressed concern over the construction of 10 hydroelectric power projects Durbuk Shyok, Nimu Chilling, Kiru, Tamasha, Kalaroos-II, Baltikulan Small, Kargil Hunderman, Phagla, Kuln Ramwari and Mandi.

"Therefore, all these projects have been made part of the PCIW meeting during which the Pakistani Indus water commission's team, headed by Syed Muhammad Mehr Ali Shah, will reiterate its objections and seek reply/justification from the visiting Indian delegation, explained the official.

"Moreover, both countries will also resume talks on Pakal Dul and Lower Kalnai projects, he added.

Since annual meetings, under the treaty, are to be held before March 31 each year; alternately in the two countries, the Pakistani delegation had paid a two-day visit to New Delhi from March 23 to 24 last year.

During the meeting, the participants discussed Pakistan's objections to the designs of Pakal Dul, Lower Kalnai and other hydroelectric projects, including 19MW Durbuk and 24MW Nimu-Chilling plants, and other data-related issues.

The Indian side had shared some information/documents related to 1,000MW Pakal Dul and 48MW Lower Kalnai hydropower projects with Pakistan.

It had agreed on getting the site of the controversial KishanGanga hydropower project inspected by Pakistani experts, the report said.

According to the treaty, India has been given the right to generate hydroelectricity through run-of-the-river projects on the western rivers subject to specific criteria for design and operation.

The pact also gives the right to Pakistan to raise objections to designs of Indian hydroelectric projects on the western rivers. Pakistan has raised objections on the design of these projects.

India, however, asserts that the design of the project is fully compliant with the provisions of the Indus Waters Treaty (IWT) and certified by the Central Water Commission and the Central Electricity Authority, the apex organisations of the country in the field of water resources and power.

Under the Indus Water Treaty (IWT), all the waters of the eastern rivers - Sutlej, Beas, and Ravi - amounting to around 33 million acre feet (MAF) annually is allocated to India for unrestricted use.

The waters of western rivers - Indus, Jhelum, and Chenab - amounting to around 135 MAF annually have been assigned largely to Pakistan. India is permitted to construct the run of the river plants on western rivers with limited storage as per criteria specified in the treaty.

Under the provisions of Article VIII(5) of the Indus Waters Treaty, the Permanent Indus Commission is required to meet regularly at least once a year; alternately in India and Pakistan. The last meeting of the Commission was held on March 23-24 2021 in New Delhi.

‘Above normal’ max...

of northwest India will be higher during summer; while heat waves will be comparatively lesser in the Indo-Gangetic plains," IMD Director General Mrutyunjay Mohapatra said.

"During the upcoming hot weather season (March to May), normal to above normal minimum temperatures are most likely over many parts of northwest India, some parts of northeast India, some parts of central India, east coastal region and

some areas along the foothills of the Himalayas," the IMD said in a statement.

During March, normal to below normal maximum temperatures are likely over most parts of Peninsular India and east and northeast India, whereas above normal maximum temperatures are forecast over many parts of western and central India.

Minimum temperature expected to be above normal in most parts of northwest and west India.

No heat wave is predicted in the northern plains in March.

For the plains, a "heat wave" is declared when the maximum temperature is more than 40 degrees Celsius, and at least 4.5 notches above normal.

A "severe" heat wave is declared if departure from normal temperature is more than 6.5 degrees Celsius, according to the IMD.

The IMD also said India recorded 44 percent more rainfall in the winter season.

Heavy rainfall events (15) in the country in February were the lowest in four years, it said, adding that most heavy rainfall events were concentrated in Kerala and Jammu and Kashmir.

The country saw 18 events each of heavy rainfall in 2021 and 2020 and 82 in 2019.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23. It surpassed the one-crore mark on December 19. India crossed the grim milestone of two crore on May 4 and three crore on June 23.

The 180 new fatalities include 110 from Kerala and 20 from Goa.

A total of 5,14,023 deaths have been reported so far in the country -- 1,43,701 from Maharashtra, 65,333 from Kerala, 39,950 from Karnataka, 38,004 from Tamil Nadu, 26,122 from Delhi, 23,456 from Uttar Pradesh and 21,176 from West Bengal.

The health ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

Centre appoints Waqf Board members for J&K

SRINAGAR: Centre Government on Tuesday nominated five persons as members of the Waqf Board for J&K Union Territory. In a significant step towards the constitution of the Waqf Board in Jammu & Kashmir, the Union Minority Affairs Ministry has appointed five persons as members of the body entrusted with maintenance of religious properties of Muslims in UT.

According to a notification, Dr. Darakshan Andrabi has been appointed as chairperson of the Board. The notification states that Andrabi has been appointed under clause (a) of sub-section (1) of section 14 of The Waqf Act-1995. Syed Muhammad Hussain has been nominated as member of the Board under clause (C) of sub-section (1) of Section 14 of the law governing constitution of Waqf Boards in States and UTs. Dr. Ghulam Nabi Haleem and Sohail Kazmi have been appointed as members of the body clause (d) of sub-section (1) of section 14 of the law. The Centre has also nominated Nawab Din (Regional Director Survey and Land Records, Udhampur) as member of the body under clause (e) of sub-section (1) of section 14 of the Waqf Act. It is worthwhile to mention that the laws governing Waqf properties in Jammu & Kashmir were repealed in August 2019 through the Jammu & Kashmir Re-organisation Act.

Over 100 terrorists, associates on radar in J&K; Ops against them soon

NEW DELHI: Over 100 terrorists and their associates are on the radar of the security forces which will soon launch an operation against them in Jammu and Kashmir, sources in the security grid said on Tuesday.

According to sources, these terrorists are hiding in the villages and forest areas in South Kashmir and only come out to execute an attack on the security forces or targeted civilians. The recee is mostly done by the OGWs, they added.

The security officials deployed in Kashmir Valley further said that despite the fact that a large number of terrorists were killed in the operation last year, Pakistan supported terrorists groups like Lashkar-e-Taiba, Jaish-e-Mohammed, Al-Badr and Hizbul Mujahideen have been sending more terrorists in the Valley. "To prevent local youths from joining terror groups is also a major challenge for the security forces," the officials said. They also said that last year, the security grid in Kashmir Valley made robust counter attack and drones were used to oversee the areas, but to identify terrorists in forest is still a challenge for them.

The intelligence agencies have identified 'some locations' near Srinagar and Baramulla districts and a coordinated operation against these terrorists are being planned at the earliest. The J&K Police's Special Operation Group will be leading the operation along with central security forces. According to the messages intercepted by the intelligence agencies, Pakistan's Inter-Service Intelligence (ISI) officials are annoyed with the terrorists in J&K for not doing 'something big' and forcing them to execute a major terrorist attack. Recently, Jammu and Kashmir Police recovered a cache of weapons possibly dropped from a drone along the International Border in RS Pura sector after which a massive search operation was launched by the SOG of J&K Police. Two magazines, 70 cartridges, one pistol, three detonators, three remotely controlled IEDs, three bottles of explosives, a bundle of cortex wire, two timer IEDs and six grenades were recovered from Treva village in Arnia sector. This indicates the vicious plan of the ISI to disrupt the peace and developmental works in the Union Territory of J&K, the officials in the security forces said.

Goutam and a team led by Assistant Sub Inspector rank officer was sent to Chandigarh for recovery of minor. With help of local Police, the team raided all suspected places and recovered the missing minor girl from clutches of accused in Chandigarh besides arresting him on the spot.
