Message

Forests of Jammu and Kashmir are renowned for their diversity, in type and functions. Ranging from the tropical dry deciduous forests, in lower altitudes to Alpine vegetation at higher altitudes, the flora and fauna of the Union territory is very diverse. With nearly, 50% of the geographical area being forest, socio-economic landscape of J&K, is enriched with forested ecosystem; J&K is intimately connected with its forests, for drawing economic and ecological sustenance.

Inarguably, forests are renewable and have had been the purveyors of livelihood, since times immemorial; however, forests are not infinitely available, to service the needs of people, and there is always a tipping point, beyond which any forest ecosystem degrades.
