437 vaccinated, 1500 samples collected in Ramban

RAMBAN: As per District Immunization Officer, Ramban, Dr. Suresh the Health Department on Sunday administered covid vaccine doses to 437 persons, including 177 children in the 15-17 years and 250 in 12-14 age group in the district.

Continuing the enforcement drive to implement Covid protocol, the Enforcement teams fined scores of violators for roaming without wearing face masks and not maintaining physical distance.

The enforcement teams, in their respective jurisdictions, recovered a fine of Rs. 20,900 taking the total amount fined since April 1, 2021 to Rs.99,48,050.

The Enforcement officers urged the people to wear face masks and maintain physical distance besides taking Covid vaccination doses at their nearest CVC.

As per daily bulletin issued by the Chief Medical Officer, Ramban, Dr. Mohammad Fareed Bhat, the Health Department has collected 1500 samples including 490 RT-PCR and 1010 RAT samples besides administering Covid vaccine to 437 persons at various dedicated Vaccination Centres in the district.

ADVISORY/ APPEAL

Through the medium of this notice it is informed in light of the increasing Traffic volume on day to day basis , the general public especially the motorists / vehicle operators shall keep their vehicles parked in appropriate parking slot and avoid the illegal/wrong parking on either side of the roads.

Vehicle operators are advised that Vehicles found wrongly parked road shall be towed/seized or appropriate action under the provisions of amended Motor Vehicle Act shall be taken accordingly.

The penalty against wrong parking/obstructing traffic under the provisions of MV Act/rehri 1988 (amended by Act. No. 32/2019) u/s179,117/122/177 are Rs. 5000/- and punishable u/s 177.

The JDA Mutli layer parking Bus Stand/Indira Chowk having 1212 LMV's parking capacity also exists in the core of City area and motorists/vehicle operators shall get their vehicles parked in the parking area so that the roads of the surrounding area are kept absolutely free for road users.

keep the vehicles safe and secure, vehicle operators shall park their vehicles in appropriate parking slots / not beyond themarked white line of road wherever applicable as per their convenience and not on roads in any manner.

The general public/shopkeepers of Jammu City shall abstain from wrong parking on roads.

The general public especially the shopkeepers/owners of the private commercial establishments of Talab Tillo-Jewel Chowk- Janipur-Sarwal- New Plot- Rehari- K.C Crossing- B.C.Road/ Bus Stand-Gumat Bazar- Vinayak Bazar, Science College Road, Prem Nagar-Gujjar Nagar- Prem Nager- Circular Road, Palace Road -Parade-Kachi Chowni, Shalamar-Indira Chowk-Super Speciality Hospital Road-Maheshpora-Bakshi Nagar bazaar etc. are parking their vehicles on the roads which cause chaos and obstruction.
