Dhantalab for the year 2021-22 as shown against each as per the annexure "A" enclosed, with the following term and conditions.

TERMS AND CONDITIONS:-

1. Quotations should be super scribed on the envelope as Quotations for harvesting /stacking /turning /Storing upto respective sheds of Rabi Oats Fodder Crop and should be addressed to Assistant Director Govt. Sheep Breeding Farm Panthal with the full name and address of Quotationer recorded on the envelope.
2. Quotations can be delivered in person, by post / through courier against the proper receipt in the office of Assistant Director Govt. Sheep Breeding Farm Panthal by or before 02.04.2022 during office hours upto 4 P.M on any working day.
3. Quotations received after the last date and time shall not be entertained in any case. If this day happens to be holiday next working day shall be considered.
4. The committee constituted for the purpose of tendering etc. reserve itself the right to accept or reject the quotations as a whole or part of quotations without assigning any reasons thereof. Quotationers shall quote their rates, both in words and figures, inclusive of all taxes/ charges on Quintal basis for each operation/work. The successful Quotationers shall have to execute the agreement with the department within 07 days after acceptance of their Quotated rates, in which the term and conditions shall form integral part of agreement.
5. If approved contractor fails to execute the job within stipulated period, the full or remaining part of the work shall be arranged through other source at the risk and cost of defaulting quotationer after serving notice to him/ her/them. The penalty upto 10% of default shall be recovered from the firm (successful quotationer).
6. The payment of the produce shall be made after weighment by the committee.
7. All remittance / Bank charges shall be borne by the Quotationer if payment is made through Bank draft.
8. The successful Quotationer shall not assign or sub let the work or part of the contract sanctioned in his favour to any individual or agency.
9. The Department reserves the right to keep the rates valid for a period as deemed fit, which shall not exceed in one year from the date of its sanction.
10. The Assistant Director, Sheep Breeding Farm Panthal shall be the final authority in respect of rejection or granting execution for delayed job or any other matters connected with the contract.
