



CRIME REPORT**Cyber Police Jammu nabs accused involved in insurance fraud case****STATE TIMES NEWS**

JAMMU: Cyber Police Jammu on Friday arrested a fraudster involved in several frauds of Rs 2,34,800.

As per details, on January 22, 2021, a complaint was lodged at Cyber Police Station Jammu, by one Sneh Lata, a senior citizen, wherein she alleged that an unknown fraudster impersonating as official from insurance department convinced her that an insurance claim is due against her deceased husband who was a retired Government Officer. The complainant, being senior citizen, got trapped and consequently lost her hard earned money amounting to Rs 2,34,800 to fraudster on one pretext or another.

On this, FIR no. 22/2021 under sections 66-D of IT Act read with 420, 120-B of IPC was registered at Cyber Police Station Jammu for indepth investigation. During investigation, a fraudster namely Sukhdeep Singh alia Sonu, son of Iqbal Singh, resident of Guru Nanak Nagar, Patiala, Punjab was zeroed in and arrested successfully by team of Cyber Police Station Jammu. Further investigation is going on to ascertain involvement of accused in other cases as well as to unearth involvement of other accused persons in case.
