Dr. Shashi Sudhan Sharma, Principal GMC, Jammu, Dr. Elias Sharma, HoD Urology, SSH, Jammu and Dr. Sanjeev Puri, Joint Director, SOTTO J&K were present on the occasion.

The team assessed the transplant facility in the department of Urology and Nephrology in SSH and all the departments in GMC which are involved in transplantation as per the pre-

scribed parameters of side for getting Kidney Transplant. Dr. Shashi Sudhan Sharma, said that GMC is well equipped with all requisite infrastructure, experts and other facilities involved in kidney transplantation for starting kidney transplant unit in the institution. She expressed hope to get registration from the authorities for performing

Kidney Transplantation here soon.

Dr. Elias Sharma said that the department will start conducting live kidney transplantation as soon as the registration is done. "Patients in need of a Kidney Transplantation will have to register themselves with this institute or State Organ and Tissue Transplantation Organization (SOTTO) J&K to avail the facility", he added.

Administrator, Ashwini Khajuria, Dr. Shazia Wafai, Senior Regional Director, RoHFW, Heads of Departments and Medical Superintendents of GMC and SSH were also present during the inspection.


Regarding - Mandatory modification of license

Last Date - 31<sup>st</sup> March, 2022

**Who are required to modify their license?**

1. **Manufacturers (including repackers and relabellers) having licenses issued through old methodology (granted from FLRS) have to shift to product selection methodology of FoSCoS.**
2. **Manufacturers holding state licenses for products under Nutraceuticals, Health Supplements, Special Dietary & Medical Use Foods, Functional and Novel Foods Regulation have to shift to Central License.**
3. **License number will not change on modification.**
4. **Wef 1<sup>st</sup> April 2022 - above stated manufacturers (who have not modified their license) will not be allowed to file renewal application of their existing licenses. File application for modification of license through FoSCoS portal i.e. <https://foscos.fssai.gov.in> or call us @1800112100 in case of queries.**
