

## CRIME REPORT

### 2 teachers suspended for exchanging blows, hurling abuses

**ANANTNAG:** Two teachers exchanged blows and hurled abuses at each other inside a school in Anantnag district over some personal issue leaving students petrified. The incident took place in Government Middle School Shoul- Batengoo village on Saturday.

In a video, which went viral on social media, two teachers can be seen pushing each other, with colleagues trying to pacify and taking them apart. The duo can also be heard threatening and hurling choicest abuses at each other.

The frightened students can be seen crying and running for safety even the female staff also tried to console them. The incident even attracted attention of villagers who rushed to the school and reprimanded the teachers. "Is this what you teach to the students?" one of elderly villagers can be heard.

"Where is your headmaster," another villager asked teachers who

responded by saying, "He is in a meeting with Zonal Education Officer (ZEO)." A source said the duo had been on and off indulging in verbal duels over some domestic issue before the situation turned ugly. "Why didn't the headmaster act or bring it to the notice of higher-ups earlier," the villagers questioned.

The incident also evoked a strong reaction from netizens who demanded strong action against the erring teachers. "Are these the morals, teachers inculcate to students," asked a social media user. Another wrote, "If this is the purpose of education in schools, then students are better off at home only".

Chief Education Officer (CEO) Anantnag, Mohd Sharif-u-Din informed that action has been taken against erring teachers. "An inquiry has been initiated to ascertain the facts," he said, adding that for now both the teachers have been placed under suspension.

### Jawan injured after rifle goes off accidentally

**KULGAM:** An army Jawan got injured after his service rifle went off accidentally when he was cleaning it at a camp in Kulgam on Tuesday.

As per details, the incident occurred at Army's 34 RR Camp at Behibag Kulgam and injured Jawan, identified as Vishnu, was shifted to Army's 92 base hospital for treatment. It was not immediately known if soldier suffered serious or minor injuries in incident.
