CRIME REPORT

Drug peddler arrested, 1.7 Kg Cannabis recovered

BARAMULLA: Continuing its efforts to eradicate menace of drugs, Police on Wednesday arrested a drug peddler in Baramulla and recovered contraband substance from his possession.

As per details, a party from Police Station Uri under supervision of SDPO Uri Junaid Wali, at a checkpoint established at Daichi Uri, intercepted a suspect identified as Mushtaq Hussain, son of Hussain Shah, resident of Dani Basgran Uri and on checking, 1.7 Kg Cannabis was recovered from his possession.

He was arrested and shifted to police station where he remained in custody. Accordingly, a case under relevant sections of law was registered at Police Station Uri and investigation started.

Two women among four missing persons traced, reunited with families

BANDIPORA/JAMMU: Police on Wednesday traced four missing persons including two women and reunited them with their families.

As per details, on February 22, 2022, Police Station Hajin received a written complaint stating therein that a woman namely Sheeraza Begam, wife of Ishfaq Ahmad Khan, resident of Hajin went missing from market. Accordingly, a missing report was lodged at Police Station Hajin and investigation started.

Subsequently, massive search was launched by a police team under guidance/supervision of SDPO Hajin Latief Khan and SHO Police Station Hajin Insp Zahoor Ahmad. After strenuous efforts and utilising all available technical/human resources, the woman was traced from Ashmuqam, Anantnag. After completion of all legal/medical formality, she was handed-over to her relatives.

Meanwhile, two different complaints were lodged at different police stations of Jammu including one regarding missing of a woman at Police Station Arnia and another regarding missing of a boy namely Kehar Singh, son of Sunder Singh, resident of Khour Deonian, Miran Sahib at Police Station Miran Sahib.

Accordingly, two different missing reports were registered at Police Stations Arnia & Miran Sahib and investigation started. On this, special police teams were constituted under supervision of SDPO R S Pura Surinder Singh.

Teams led by SHO Arnia Inspr Tilak Raj Sharma and SHO Miran Sahib Inspr Sultan Mirza, after putting in hectic efforts and with help of technical assistance, traced both the missing persons. Subsequently, families of both missing persons were informed and they were handed-over to their respective family members after



completing all legal formalities.

In another case, a complaint was lodged at Police Station Ramsoo by one Abdul Qayoom, resident of Sarbagni, Tehsil Ramsoo stating that his 19 years old son Rashid Ahmad went missing from his home since February 21, 2022. Acting swiftly, a special Police Team was constituted to trace missing boy and after hectic efforts, his presence was traced at Kashmiri Gate, New Delhi. A police team was deputed to trace missing boy at aforementioned location and finally, he was reunited with his family on March 1, 2022. The entire search was affected by police team led by Insp Nazir Ahmad SHO Ramsoo under supervision of Nissar Khoja SDPO Banihal with overall supervision of Mohita Sharma, SSP Ramban.

Theft case solved; 2 arrested, stolen ornaments worth Rs 7 lakh recovered

JAMMU: Police on Wednesday solved a theft case by arresting two accused and recovered stolen gold and silver ornaments worth Rs 7 lakh from their possession.

Briefing media, SSP Jammu Chandan Kohli said that in a major breakthrough Jammu Police has solved a major theft case and recoveries worth Rs 7 lakh have been made.

Giving details, SSP Jammu said, "A written complaint was lodged at Police Post Hari Market that some thieves have stolen gold and silver ornaments from a jewellery shop of one Rajinder Kapoor, son of Shiv Ram Kapoor, resident of Sarwal, Jammu". Accordingly, FIR No. 07/2022 under sections 380/457 of IPC was registered at Police Station City Jammu and investigation started.

SSP Jammu further added that special police teams of Police Post Hari Market were constituted under supervision of SDPO North Sharad Kalu and a team led by SHO City, Inspr Vijay Kumar assisted by Incharge Hari Market SI Ravi Kumar, after putting in strenuous efforts besides carrying out scrutiny of CCTV footages of areas, finally rounded up a suspect identified as Shafadul Islam, son of Mohd Furkan, resident of Nikund Vihar, West Bengal, presently staying at Gujjar Nagar, Jammu. During sustained questioning, the accused confessed his involvement in crime and on his disclosure, stolen gold and silver ornaments worth Rs 7 lakh were recovered which included 8 Kg silver and 18 gm Gold ornaments. On further questioning, the accused revealed name of one more accomplice namely Amir Suhail, son of Sekander Ali Sheikh, resident of village -Patul, district Hooghly, West Bengal, presently staying near Peerkho, who was also arrested. The arrests and recovery was done under supervision of SP North Kulbeer Handa.

18 bovines rescued, 2 smugglers nabbed
