Dear Sir,

Regarding the subject cited above it is conveyed that the above noted work namely Construction and Maintenance of road L023 Bharatgarh to Handulian (Part-2) Package No.JK05-184 Stage-II Block Nud Distt. Samba Length - 9.900 Kms stands allotted to your firm by the worthy the Chief Engineer PMGSY Jammu Vide NTP No.CEJ/PMGSY/11984-93 dated 24-08-2018. With a completion period of 20 months.

As reported by the field staff that the progress of work is very slow which is not acceptable.

Your firm has been asked so many times by the field staff to expedite the pace of work by engaging sufficient men and machinery but nothing has been done from your side.

As you know that the sunset date for completion of all PMGSY Schemes has been fixed i.e. 31-03-2022 which means this road has to be completed by the 31-03-2022 by way of laying of BT in all respect.

During the review meeting on 15-02-2022 held under the chairmanship of worthy Principal Secretary PW(R&B) Department J&K Jammu in Civil Secretariat. The undersigned faced a very embracing situation due to very low progress of work. Moreover, District Administration Samba has also taken a serious note of slow progress.

You are hereby once again directed to expedite the pace of work by engaging sufficient men and machinery at site within 3 days from the issue of this notice for its early failing which this office is left with no option to terminate your contract and impose penalty on your firm for delaying in completion of the work as per the SBD clause.

Treat this notice as final notice and further no correspondence shall be made from this office.

Treat the matter as most urgent.
