

# Old Pension Scheme need of time: USTA

KATHUA: At the nationwide call of central trade unions, J&K United School Teachers Association (USTA) also staged a protest outside Deputy Commissioner office at Kathua on Wednesday. Led by USTA and CCTU President Dr. Shashi Pal Singh, a large number of employees, teachers and temporary workers raised slogans in favor of their demands like restoration of old pension scheme regularization of all temporary workers, filling up of vacant posts etc. and against the record breaking price rise, privatization of public sector, etc.

Speaking on the occasion Dr. Shashi Pal Singh questioned the new pension policy prevailing in the country and stated that on one hand government is pursuing one nation one flag policy whereas on the other hand there

are two set of pension schemes being given to employees. He demanded immediate scrapping of new pension scheme with restoration of uniform old pension policy in favor of all the employees. He further contended that contractual form of employment is exploitation of employees and demanded single regular employment policy in the country.

Provincial President Dr. Shashi Pal Singh also raised the issue of massive price

hike of essential commodities and stated that "sky rocketing expenses" of households are adding miseries in the lives of employees especially temporary workers. He demanded controlling of inflation by reducing taxes and excise duties on various petroleum and household products.

Marching toward civil secretariat, Kathua District President USTA Rattan Singh Pathania demanded wage and regularization policy

for all temporary workers like casual, contract, Anganbadi, Mid-day meal, Asha and other scheme workers. He also

demanding enhancement in their minimum wages to Rs. 21000 per month till regularization. District Secretary USTA Shri Bodh Raj urged upon the government to enhance the budgetary support in education sector; abolition of in charging from School Education Department, regular holding of DPC of all cadre and implementation of Right to Education Act 2009 in letter and spirit. Others who addressed the demonstrators include Ram Das, Vijay Kumar, Sudesh Kumar and Vinayak Sharma.
