JAMMU: To catalyze and accelerate inclusive social and economic development through empowerment of farmers, Sher-e-Kashmir University of Agricultural Sciences and Technology - Jammu (SKUAST-J) on Wednesday signed a Memorandum of Understanding with ICICI Foundation, Mumbai. The Memorandum of Understanding was signed by Prof. J.P. Sharma, Vice-Chancellor SKUAST Jammu and Anuj Agarwal, Chief Operating Officer, ICICI Foundation, Mumbai. Both the parties mutually agreed to collaborate towards undertaking various initiatives to help underprivileged people in agriculture and allied activities in the mutually decided villages of Jammu Province.

According to MoU, SKUAST-Jammu shall take the responsibilities of implementation of activities under the programme by providing technical knowhow and support

at its different Research Stations and Krishi Vigyan Kendras (VKVs). The agrivarsity shall provide training related to agriculture, horticulture, animal husbandry, fishery and mushroom cultivation. SAVE TURTLE DOVE (Kalmuha)

Turtle Dove (*Streptopeliaorientalis*) is a small migratory bird locally known as 'Kalmuha' is listed under Schedule-I of Wildlife Protection Act, 1972. During this season, it migrates from plains to higher reaches (up to 4000 ft high) for breeding. The number of Turtle Dove is dwindling at an alarming rate as some unscrupulous elements resort to hunting of this bird which is punishable with imprisonment upto three years or with fine of Rs. 25000/- or both under Wildlife Protection Act.
