# CRIME REPORT

## Two missing girls reunited with families

JAMMU: Police on Tuesday traced two missing girls and reunited them with their families.

As per details, two different complaints were received at Police Station Arnia and Police Post Chowk Chabutra regarding missing of girls from their houses. A missing report was registered at Police Station Arnia and other at Police Post Chowk Chabutra respectively. After this, a team of Police Station Arnia under the supervision of SDPO R S Pura Surinder Singh led by SHO Police Station Arnia Insp Tilak Raj, after putting in hectic efforts, traced the missing girl. Similarly another team constituted under supervision of SDPO North Sharad Kalu and led by SHO Paeca Danga Inspr Raghubir Singh assisted by Incharge Police Post Chowk Chabutra PSI Jyoti Choudhary using CCTV footages traced the girl. Families of both traced girls were informed accordingly. After this, both girls were produced before child welfare committee and were medically examined. Finally, they were handed-over to their families after completing all legal formalities.

## Two bootleggers arrested; 82 bottles of illicit liquor recovered

JAMMU: In an act of alertness and prompt action, teams of Police Stations Nagrota and Arnia recovered 82 bottles of illicit liquor and arrested two bootleggers.

As per details, a party from Police Station Nagrota constituted by SDPO Nagrota Pardeep Kumar and led by SHO Nagrota Inspr Vishav Pratap Singh while on Naka duty at Toll post Nagrota rounded up a suspect in a vehicle (JK08B/7477). During search, 52 bottles of liquor of 250 ml each of JK Special whiskey were recovered from him. FIR No 88/2022 under section 48(a) Excise Act was registered at Police Station Nagrota and accused was arrested, who was identified as Rajinder Singh, son of Gandarav Singh, resident of Panjgrain, Nagrota.

Similarly a team of Police Station Arnia constituted under supervision of SDPO R S Pura Surinder Singh and led by SHO Police Station Arnia Inspr Tilak Raj assisted by PSI Pankaj Katoch got an input regarding sale of illicit liquor. On this police team rushed to the spot and rounded up a suspect. On search, 30 bottles of illicit liquor of 180 ml each were recovered from him along with 80 ltrs of Lahian, which was destroyed on the spot. FIR No 16/2022, under section 48(a) Excise Act was registered at Police Station Arnia and accused was arrested, who disclosed his identity as Daler Singh, son of Gurcharan, resident of Kalyana, Tehsil R S Pura.

## Minor kidnapped girl recovered within 24 hours

SAMBA: Police on Tuesday recovered a minor kidnapped girl with 24 hours of complaint registered at Police Station Purmandal.
