huge wealth by indulging in corruption, are opposing the imposition of property tax in the Union Territory, he said.

"The tax money, which is of the people, will be used for the benefit of the people. It will not be deposited in the consolidated fund of the Union Territory but in the local bodies' accounts.

"But some people raise a hue and cry. Someone said tax will be imposed in villages as well. Some of them have held responsible posts. How can municipal tax be imposed in villages?" he asked.

Sinha also said that no tax would be imposed on religious places.

"But some people have a habit of saying nonsense, these people have amassed huge alth for four-five generations by indulging in corruption. The people opposing it (municipal tax) are the ones who give Rs 5 lakh every month for their properties in Delhi and Mumbai. The people of Jammu and Kashmir do not oppose it," Sinha

Of the 5.20 lakh households, 2.06 lakh have an area less than 1,000 square feet.

No tax has been imposed on such households, he asserted.

It means 40 per cent of the population will not have to pay the tax, he said.

The second category is 1,000-1500 square feet for which a yearly tax of only Rs 1,000 will be imposed, and that too in some specific areas of Srinagar and Jammu cities. In the rest of the districts, it will be a maximum of Rs 700, he said.

There are 1.01 lakh commercial properties in Jammu and Kashmir. A maximum annual tax of Rs 700 will be imposed on only 46,000 of these. Rs 2,000 will be taxed annually from 20,000 properties in the cities of Srinagar and Jammu. The tax will be lower in other districts, Sinha concluded.

Security for everyone has been a major concern for the community, he said.

Central Govt notifies Animal Birth Control Rules 2023

JAMMU: The Ministry of Fisheries, Animal Husbandry and Dairying has notified the Animal Birth Control Rules, 2023, defining the guidelines for the management and feeding of stray dogs. According to this. the onus of dedicating feeding points for such communitv animals in their localities and apartment complexes lies with Resident Welfare Associations (RWA) and Apartment Owners Associations (AOA), respectively

The RWAs and AOAs will have to make necessary arrangements for the feeding of community dogs and cats residing in the premises or the area.

Bearing in mind the dog / cat population in the concerned area, RWA and AOA representatives shall designate feeding spots that have been mutually agreed upon.

"These feeding spots shall be far from children play areas, entry and exit points, staircases, and should be in an area which is the least frequented by children and senior citizens. RWAs or AOAs should designate feeding times depending on the movement of children and senior citizens. The designated feeder shall ensure that there is no littering at the feeding location. Designated feeders are allowed to volunteer to help vaccinate the dogs, and to assist the animal birth control programme by helping catch and release the animals," the guidelines

In case of street animals. the local authority shall be responsible for deworming, immunisation, and sterilisation, and may engage an animal welfare organisation to carry out the animal birth control programme in accor-

It also said that in case of pets, the owner of the animal shall be responsible for deworming, immunisation, and sterilisation.
