## Jammu to play equal role in governance, decision making in J&K: Rana

VIJAYPUR: Expressing happiness over realization dawning on the entire political spectrum of Jammu and Kashmir that political role of Jammu cannot be downplayed or put under the carpet anymore because of the self-centric politics of chosen and privileged few, Senior BJP leader Devender Singh Rana on Thursday said Jammu is destined to play equal role in the political discourse of the Union Territory.

"Jammu region is not community specific but it encompasses all the people of the Jammu region, irrespective of religion, race or caste", Devender Rana said at the sidelines of a function to inaugurate education enterprise in the presence of Prem Sagar Aziz former Minister and Er. Dil Bahdur Singh Jamwal, Incharge BJP Swachh Bharat Abhiyan in Vijaypur this afternoon.

When asked to react over a senior politician and Member of Parliament raising slogans of Jai Dogra and Jai Jammu in Udhampur, Rana said this vindicates the position taken by him in the recent past.

He said he had not pitched for Jammu's larger role in decision making and the political empowerment in the Jammu Declaration resolve three and half years ago to put one province against the other, or one segment of the society against the other but the historic fact of part played by

this region in socio-economic development and political awakening of the erstwhile state that had got shadowed due to decades long discrimination and neglect by the vested interests.

"Now the same lot of politicians take pride in raising slogans of Jai Jammu and Jai Dogra", Rana said, adding this is the reality of Naya Jammu and Kashmir under Prime Minister Narendra Modi, which is steadily but single-mindedly treading the path of peace and normalcy.

The nightmare of choked Valley is over and the people there are relishing the benefits of normalcy, which had been grabbed by, not only the terrorists sponsored from across the borders but also by the local actors,

## Court awards 7-yr RI to two brothers in culpable homicide case


JAMMU: Principal Sessions Bandipora Amit Sharma has awarded seven years rigorous imprisonment and fine Rs 5000 each to Mohammad Ramzan Dar and Mohammad Yousuf Dar, sons of Ghulam Mohi-ud-din Dar, residents of Ilahipora Aloosa, Bandipora who were facing trial in 304-II RPC (culpable homicide not amounting to

As per case of prosecution, on November 13, 2016 police post Aloosa received information from reliable sources that at Gurdal, two parties namely Abdul Rehman Dar, son of Mohammad Sultan Dar, resident of Illahipora Aloosa and Mohd Ramzan Dar, Mohd Yousuf Dar, both sons of Gh Mohi Ud Din Dar residents of Illahipora Aloosa were having some dispute over Aabi-awal land. On the day of occurrence,

Abdul Rehman Dar was attacked on his head by other side, causing his death. After completion of investigation challan was presented.

Principal Sessions Judge Bandipora Amit Sharma, after hearing both the sides, observed that the nature of the crime committed and manner in which it was committed can be decisive factors to decide as to whether corrective measures should be adopted or a deterrence based approach would be befitting. The sentence must adhere to the principles of proportionately of the punishment to the gravity of the offence. As the injury was inflicted on the vital part of the body of the said deceased. undue sympathy and unwarranted leniency impair the cause of justice. As the act of the accused persons falls under the category of 304 (II)

the maximum punishment which may extend to ten years or with fine or both. Whereas this fact cannot be ignored that both accused are agriculturists by profession and have no criminal record. "Keeping in view age of accused, the manner in which the said act was committed by them and this fact is also of relevant consideration that both the deceased as well as the accused persons are in relation with each other. So taking all these factors in view, the accused persons while being convicted under Section 304 (II) of RPC are hereby sentenced to; Rigorous imprisonment for seven years and a fine Rs 5000 each for commission of an offence under 304 (II) of RPC. In case of default in payment of fine, the accused would undergo further imprisonment for one month each," the Court

Even after 14 years of launch Jan Aushadi Medicines have not taken even 0.5 pc of Pharma Market? Why so when Jan Aushadhi medicines bear very genuine price tags as compared to branded generic medicines?

espite India being one of the leading exporters of generic medicines to the world, the majority of Indians have been lacking due and sufficient access to fairly priced allopathic medicines ( even which are patent free). Instead the branded generic medicines were being sold and are still being sold in India at highly / unreasonably inflated prices , as high as even 500 to 700 % more than there could be a fair price for a patent free drug with reasonable margin for the seller. Same drug (active ingredient) is sold by different pharma companies under different brand names even with inflated MRPs but even highest MRP marked drug is sold to the patients with the help of prescription writers in the absence of there being any effective implementation of the practice to write the prescription by generic name of drug even in government hospitals / institutions.

Branded Generic medicines/patent free were being sold and are still being sold in India at highly / unreasonably inflated prices , as high as even 4to8times more than a possible fair price for a patent free drug ( (Amlodipine - 5mg Tab Jan Auashadi Rs.5/ 10 Tab, Amodep-5 Rs.15.55/14 Tab, Amlokind-5 Rs. 22.15/ 10 tab, Amanat- 5  $\mathrm{Rs}.22.37/10$  tab , Amlip-5  $\mathrm{Rs}.24.97/10$  tab, 74.93/30 tab, Amlovas 5 \*Amtas 5 Rs. Rs.37.46/15 Tab, Mold 5mg Rs.39/10 Tab, Samloday 5 mg  $\,$  Rs.53.56/10 Tab ,\*Espin-5 Rs.66.50/10 Tab ). Medicines if prescribed under generic/ technical name/ chemical name would

make the manufacturers of a medicine using same technical grade material to mark their drug with a competitive MRP which most of them generally do not do when

they market with a brand name with the assistance of the 'Prescription Writer'. Unfairly marked MRP fleece all of the society, whether rich or poor, ofcourse the rich may be able to bear the burnt and the economically weaker / poor may be further crushed or may 'skip' taking timely treatment. No doubt with coming up of Jan Aushadhi some manufacturers have either brought down their branded product MRP or atleast they have not increased further but that is too less an achievement for a 15 vr old Parivoina.

No doubt there has been some increase in the sale of 'generic' medicines after BPPI/ Pharmaceuticals and Medical Devices Bureau of India (PMBI) was given the work of making available 'patent' free technical grade drugs labelled with fairly decided MRPs through Jan Aushadhi outlets in late 2008.

But looking at the facts like (i) that the JA generic drugs are genuinely priced much lower than those sold under brand names by private companies (ii) the Pharmaceuticals and Medical Devices Bureau of India (PMBI) provides financial cost & infrastructure support to those who take to starting such shops/ Kendras the sales have been very much frustrating. Had the Member Pharma PSEs of BPPI/PMBI , the Administration in Health & Medical Education Departments and political mas-

Surely Prime Minister is not being provided real feedback on ground situations and it appears he is 'single handedly' taking stresses on all economic & social fronts. Even after 2016 when PM has been taking the JA programme like his very very personal 'child' and working hard to promote it all these 7 years the people below have surely not worked truthfully and a few lakhs of crores of INR have been fleeced from the patients. Even seven years is too much of period.On the initiated of Prime Minister of India that since 2019 now the 7th March has been declared as Jan Aushadhi Diwas
