- Whereas, on your Selection as Constable, in J&K Armed Police in terms of PHQ J&K Order No. 2844 of 2002 Dated:- 24-07-2002 and on your furthr adjustment in JKAP-5th Bn., Vide APHQ Order Endstt No. APHQ/ Pers/ Apptt-04/2002/16197 Dated:- 25-07-2002, you were provisionally appointed as Constable by Commandant JKAP-5th Bn. Vide his Office Order No. 1035 of 2002 Dated:- 28-11-2002 and you joined the Department on the same date i.e 28-11-2002.
- Whereas, you remained posted in several Battalions/ Wings and Instantly you are posted in this unit since 29-04-2021, following your repatriation from Traffic wing and Subsequent your further adjustment in this unit Vide APHQ Order No. 329 of 2021 Dated:- 17-04-2021.
- Whereas, while your deployment at Battalion headquarters IRP-10th Bn. at APC Mattan on the pretext of having some urgent work at your home and on your request, (6+1) Days casual leave was sanctioned in your favour by Coy Commander Concerned w.e.f 11.02.2023 and you proceeded to avail the same on the same date i.e 11.02.2023.
- Whereas, after expiry of granted leave period, you were due to report back for duties on 18-02-202 FN which you failed to do so and accordingly your absence from leave stand diarized in unit Daily Diary vide DD report No. 09 dated:- 18-02-2023 at 1159 hours.
- Whereas, following your prolonged absence, you were informed through your concerned Police Station vide this office signal No. Estv/ PF-327/IRP-10th/2023/6441 Dated:- 18-03-2023, to resume your duties, but all in vain, as you neither responded the communication nor resumed your duties till date.
- Whereas, the act on part of you, as enumerated above is severe service misconduct/ dereliction of duties, despite being an adept member of disciplined force and is unbecoming on your part and not only speaks your disinterest to serve the department anymore, but also warrants a on your part and not only speaks your disinterest to serve the department anymore, but also warrants a strict departmental action to be taken against you under rules, including removal from Govt. Services.
- Whereas, on Perusal of your Character Roll, it reveals that from the date of your initial appointment on 28-11-2002 to till date you have been awarded (02) minor Punishments in the shape of censure in the year 2006 and also (04) times warned for your absence from duties, apart from it (186) days out of your service have been treated as Diesnon also for remaining adsent from duties, from which it is evident that you have not remain duty bound/ law abiding in previous service carrier too.

Provides you one more opportunity through the medium of this notice to resume your duties within three days positively after the execution of this notice and to show your cause of non-resumption of duties as well as regarding your whereabouts during the absented period. Your reply along with defense, if any should reach to this office within (03) days positively, failing to reply within given time limit, it shall be presumed that you have nothing to say in this behalf and are not interested to serve the department anymore and subsequently, as per the procedure, proceedings for your Removal from Govt. Services shall be processed without issuing further notice(s) in order to save the precious time of the department as well as Govt. exchequer.
