8 narco & bovine smugglers arrested

SAMBA: Major success has been achieved by Samba Police under the guidance of SSP Samba Benam Tosh



and eight notorious smugglers of heroin and bovine were arrested red-handed at different places in Samba district. Heroin worth rupees Rs 75,000 has been recovered and 13 bovines were rescued. Eight arrested smugglers have been identified as Sukhdev Raj alias Sukha, son of Prem Nath, resident of Denth Nud Samba; Sunny Jammal, son of Subash Chander, resident of SeirJhaganu



Udhampur; Atul Singh, son of Gopal Singh, resident of Seir Jhaganu Udhampur; Manzoor Ahmed, son of Mohd. Sulman resident of Channi Mansar; Mohd. Usman Khatana, son of Mohd. Jamal Khatana, resident of Chowadi Sainik Colony Jammu; Tariq Hussain, son of Basharat Ahmed Boked, resident of Gadval Tehsil LaranDistt.Anantnag at present Bathindi, Jammu; Irshad Hussain, son of Muzaffer Hussain, resident of Karyani Talab Narwal Jammu and Mohd. Imran Doie, son of Mohd. Mumtaz Doie resident of Anantnag at present Karyani Talab Narwal. Three separate FIRs were registered at Police Station Samba and Police Station Bari Brahmana and investigation started. Eight heroin & bovine smugglers were arrested by PSI Deepika Jalotra, PSI Diviya Bharti, PSI Abrar Ahmed, PSI Rakesh Singh, SHO Samba Rajeshwar Singh, SHO Bari Brahmana Sunil Sharma under the supervision of SDPO Bari Brahmana Rahul Nagar, DySP Hqrs Samba Mohd Usman and Additional SP Samba Surinder Choudhary.

Bootlegger nabbed with 14 bottles of liquor

BASOHLI: Police on Monday arrested a bootlegger and recovered/seized 14 bottles of illicit liquor from his possession.

As per details, a police party led by Insp. Jaswinder Singh SHO Basohli under the supervision of SDPO Basohli Aakash Kohli during Naka checking at Bus Stand Basohli, apprehended a suspect namely Kuldeep Raj, son of Sardara Singh, resident of Jahankher Tehsil Basohli. On checking, a total of 14 bottles of JK Special Whisky (750 ml each) illicit liquor were recovered from his possession. The accused was arrested and FIR No 18/2023 under section 48 (A) Excise Act was registered against him at Police Station Basohli.

7 drug peddlers arrested; contraband, cash recovered

BARAMULLA: Acting tough against drug dealings, Police on Tuesday arrested 7 drug peddlers including a lady drug peddler in various actions and recovered contraband substances & cash from their possession.

As per details, a party of Police Station Sheeri at a checkpoint established at Sheeri Market arrested three drug peddlers identified as Zubair Ahmad Pandith son of Mohd Hayat Pandith resident of Gantamulla Payeen, Waheed Bashir Lone son of Bashir Ahmad Lone & Mushtaq Ahmad Lone son of Ali Mohd Lone, both residents of Fatehgarh Sheeri. During search, 63 gm Brown Sugar was recovered from their possession. They were shifted to police station where they

remained in custody. In another similar action, a police party at a checkpoint established at Boniyar intercepted a vehicle bearing registration number JK05L-3829 with four persons on board, later identified as Ikhlaiq Mir son of Ahmad Mir, Kabir Ahmad Awan son of Muzaffar Ahmad, both residents of Daragutliyan, Abdul Qayoom Khan son of Sarfaraz Ahmad resident of Bela Salamabad and Muneeba Younis daughter of Mohammad Younis Sudan resident of Uranbowa. During search, 60 gm Heroin and cash amounting to Rs 50,000 (proceeds of narcotic crime) was recovered from their possession. They were arrested and the vehicle used in commission of crime was also seized. Accordingly, cases under relevant sections of law were registered in respective police stations and investigations started.

Theft case solved; 4 arrested, stolen property worth lakhs recovered

BUDGAM: Police on Tuesday solved a theft case by arresting 4 accused persons involved in the commission of crime and recovered stolen property worth lakhs from their possession.

As per details, on February 1, 2023, Police Station Magam received a written complaint from one Jameel Jansheed Magray son of Abdul Ahad Magray resident of Batpora Kanihama stating therein that during the intervening night of 31st Jan-1st Feb-2023, some unknown thieves have stolen iron rods weighing about 93 quintals lying outside his Iron and cement store at Batpora Kanihama. Accordingly, FIR number 13/2023 under relevant sections of law was registered at Police Station Magam and investigation initiated. During the course of investigation, officers with the help of technical evidences zeroed in on one suspect identified as Muzzaffar Ahmad Khatana son of Mohammad Rafiq Khatana resident of Peerah Ramban. During sustained questioning, he disclosed that he along with 11 accomplices have stolen Iron bars weighing around 93 quintals from Batpora Crossing and have used five vehicles including 4 trucks and a Santro Car in commission of crime. He also disclosed that they have sold the stolen property to a scrap-dealer at Batote, Ramban. Subsequently, the scrap dealer was also arrested in instant case and stolen property was recovered. So far four accused persons have been arrested in the case besides, a truck bearing registration number JK14B-1095 used in commission of crime has also been seized. The other arrested were identified as Sadiq Hussain son of Azeem Bakarwal, Mohammad Irfan Bokra son of Abdul Aziz Bokra, both residents of Peerah Ramban, Mohammad Mughal Bokra son of Abdul Rasheed Bokra resident of Samba Jammu and efforts are on to nab them.

Opium field seized, accused arrested

JHAJJAR KOTLI: Police on Tuesday seized an opium field and arrested an accused.

7 vehicles seized for illegal mining

20 years old youth murdered

JAMMU: A 20-year-old youth was murdered in Gajansoo area of Jammu district on Tuesday. According to detail, Uday Chib, son of Surjit Singh, resident of Gho Manhasaa and Sumit Sharma, son of Kuldeep Raj, resident of Machine Domana, when reached Saharan area on Tuesday morning along with their colleagues, a dispute broke out between them. The matter increased so much that Sumit took out a sharp-edged weapon and attacked Uday Chib. After injuring him, accused fled from the spot. During investigation, it was found that Sumit was having a dispute with Uday's friend Vansh. Sumit is a student of class 11th and is minor as per records. Vansh and Sumit were having a dispute for many days. They gathered in Saharan for the same where Vansh called Uday from his house along with other companions. From other side, Sumit also reached Saharan along with his companions, after which the matter worsened. A case has been registered in this regard.
