The Lt Governor said the highest ever investment of Rs 1,547.87 crore was received during the last 10 months of this year, while 500 startups have come up during the last three years with the youth of Kashmir coming up with new startups on daily basis. the Explosive Substances Act and the Unlawful Activities (Prevention) Act following thorough investigation into the explosions inside two parked buses in Udhampur district on September 28 and 29, the official said.

The spokesperson said the two LeT operatives have also been charged for their efforts towards revival of terrorist activities in Jammu by carrying out recruitment from the pool of Overground Workers and surrendered terrorists as well as activating and motivating them to carry out terrorist acts.

from across the international border and was collected by Sheikh in Kathua district. "Bhat trained Adil in cyberspace on how to prime the IEDs. On September 28, Sheikh planted two IEDs in two different buses, which were plying between Basnatgarh and Udhampur. One blast took place around midnight on September 28 and the other in the early hours of September 29," the spokesperson said.

NEW DELHI: One "Rahul Gandhi K E S/o Valsamma" figures in an Election Commission list of persons disqualified from contesting polls for failing to lodge account of election expens-

He had contested the 2019 Lok Sabha elections as an Independent and had polled 2196 votes from the Wayanad seat in Kerala from where Congress leader Rahul Gandhi won with over 7 lakh votes. It is common for namesake independent candidates to contest against established leaders but all of them need to submit account of elecmandatory requirements under EC rules and the Representation of the People Act.

Incidentally the Congress leader was also disqualified last week, but for another

Corruption by public servant 'gigantic problem': Court

MUMBAI: Corruption by a public servant has become a "gigantic problem" and has a "deep and pervasive impact" on the functioning of the entire nation, a special court here has said while sentencing an Income Tax Department officer after convicting her in a Rs 75,000 bribery case.

Special Central Bureau of Investigation (CBI) court judge M R Purwar on Wednesday held Preetha Babukuttan guilty of the offence under the Prevention of Corruption Act and sentenced the 52-year-old officer to four years of rigorous imprison-

The prosecution said the officer had initially made a demand of Rs 1,30,000 in March 2015 to settle the tax liability of the complainant, who runs a partnership firm.

She had told the complainant that his tax liability was around Rs 5 lakh and she would try to bring it down to Rs 55,000, for which she demanded Rs 1,30,000. After negotiations, she reduced the amount to Rs $1,\!00,\!000$ and later to Rs 75,000.

However, the complainant was not willing to pay the bribe and brought the matter to the notice of the Anti-Corruption Bureau (ACB) unit of the CBI. Accordingly, a trap was laid and the accused was caught while

accepting the bribe amount of

Rs 75,000. The court, after examining witnesses and evidence produced by the prosecution, held that it is clear that the accused had demanded, accepted the illegal gratification from the complainant which is other

than her legal remuneration. "She obtained for herself the pecuniary advantage by corrupt or illegal means and by abusing her official position which certainly amounts to criminal misconduct by the public servant. Therefore, it is concluded that the prosecution has proved beyond reasonable doubt," the special court said.

It observed that while considering the sentence and punishment to be inflicted on the accused, certain aspects, such as nature of offence, the age, character and antecedents of the accused need to be kept in mind. The court said that undisputedly, no material is produced on record by the prosecution to show antecedents of the accused.

"However, at the same time the nature of the offence is serious. The dishonest intention and abuse of official position to grab money as gratification is alarming. Corruption by public servant has become a gigantic problem. It has a deep and pervasive impact on the functioning of the entire country," the court said.
