- Women candidates in the age group of 18-37 years as on 01-01-2024 shall be considered for the post The candidate should be a domicile of the UT of J&K.
- The candidate should be a resident of the electoral ward where AWC is situated. Name in the voter list for the ward shall be considered as the proof of residence of the candidate. In case the name of the candidate appears in Voter list along with her parents, then she must provide certificate of being unmarried issued by the concerned Tehsildar. Wherever, there is any dispute of residence for any reason, then a residence proof certifying the ward of residence from the concerned SDM/ACR shall be considered. Minimum qualification for Sahayikas shall be Matriculation.
- In case no matriculate candidate is available in the ward, candidates with qualification not less than 8th standard


