

DM Jammu mandates weapon deposit for 4914 Arms Licence holders

JAMMU: A Screening Committee, led by District Magistrate Sachin Kumar Vaishya, has scrutinised 4914 Arms Licences and instructed the holders to submit their weapons to ensure the peaceful conduct of the General Elections for Lok Sabha.

An order has been issued by the DM in this regard and the Senior Superintendent of

Police has also been asked to ensure implementation of the order.

The arms/ weapons are to be deposited within a period of 7 days and the concerned SHOs shall intimate the licence holders for compliance.

These licence holders fall under the categories a) Arms License of the persons released on bail; b) Arms License of the persons having

criminal offences; c) Arms License of the persons involved in rioting at any time but especially during the Election; and d) Other licence holder(s) having potential to disturb the Election Process.

The list of the licence holders shall also be published in the media and displayed at the office of SSP, SDMs, Tehsildars and Police Stations.

Subject: Mandatory disclosure of details of outsiders working in Industries/ construction companies/ business establishments/ domestic helpers/ tenants (commercial and agricultural) & Police verification thereof.

Order No: 02 of 2024
Dated: 14. 03.2024

Whereas, during the meeting of District Level Standing Committee on Border Security, Senior Superintendent of Police took up the matter of need for issuance of prohibitory orders for mandatory disclosure of details of outsiders working in Industries/ construction companies/ business establishments/ domestic helpers/tenants (commercial and agricultural) as there have been instances of anti-national / anti- social elements seeking hideouts in the residential areas in the guise of tenants / domestic helpers; and

Whereas, BSF authorities have also on earlier occasions raised concerns about the settlement of some outsider families close to the international border area, who have taken the agricultural land on rent basis from the farmers of the border area and are suspected to be involved in activities detrimental to national security and similar prohibitory orders issued earlier vide No. 01 of 2024 dated 04.01.2024; and

Whereas, during the deliberations at recent meeting of District Level Standing Committee on Border Security, it was observed that it is necessary that orders for mandatory disclosure need to be reiterated and again measures need to be taken to make the land owners/ property owners/owners of business establishments accountable before renting out/ making available their premises to outsiders working in Industries/ construction companies/business establishment /domestic helpers/commercial and agricultural tenants; and

Whereas, I consider the threat posed by such adverse elements as imminent danger to human safety, that warrants immediate preventive measures under section 144 of IPC.

Now, therefore, for the aforesaid reasons, and by virtue of powers vested in me under section 144 of CPC, 1, Abhishek Sharma, IAS, District Magistrate, Samba do hereby order and require all landlord(s), landowner(s) owner(s) of properties, owner(s) of business establishment, attorney holder(s), person(s) in charge of properties in any capacity (hereafter called as owners) located in jurisdiction of district Samba, to comply strictly with the following directions:

1. All owners shall after the issuance of this order and within ten days of letting/ sub-letting/ renting out his/ her/ their premises/ house / business establishment or part thereof to any tenant(s) as per the Declaration Form (annexed herewith), to be signed by both the owner(s) and the tenant(s), to the concerned Police Station, either in person or by registered post addressed to DMS/JC/2022-23/4279-92 OFFICE SAMBA (OUTSIDE SECTT)
2. The owners who have already let / sub-let/ rented out their house(s)/ business establishment or part(s) thereof to any tenant(s) on any date prior to the issuance of this order, shall within ten days after the issuance of this order, submit without fail the detailed particulars of the outsider(s) working in Industries/ construction companies/business establishment / domestic helpers/tenants (commercial and agricultural) as per the declaration form to the concerned Police Station.
3. It is clarified that individuals relating to all arrangements of letting or sub-letting the property like Paying Guest, Tenants (Commercial and Agricultural) etc. shall also be covered by this order.
4. Owners who have allowed Jhuggi's in their lands shall also be required to disclose the detail as per the declaration form.
5. Every SHO in district Samba shall conduct verification of outsiders working in Industries/ construction companies / business establishment / domestic helpers/tenants (commercial & agricultural) and also maintain a separate register for such purpose.
6. Every Tehsildar, through the Institution of Lambardar, Chowkddar and through PRI Members shall disseminate the information about this order and the need for mandatory disclosure of details of outsiders especially in border villages.

Any person found violating the aforementioned order shall be dealt with, in accordance with law. Since it is not possible to serve the order individually, it is being issued ex-parte. Sr. Superintendent of Police, Samba shall ensure enforcement of said order in letter and spirit

The order shall come into force with immediate effect and shall remain in force for a period of two months from the date of its issuance, if not withdrawn or rescinded earlier.

Sub: Imposition of ban on carrying weapons during Lok Sabha Election-2024.

ORDER

Whereas, in view of the Lok Sabha Election-2024, prohibitory orders under section 144 of the Criminal Procedure Code, 1973 requires to be issued banning the carrying of licensed arms which is essential to ensure law and order.

Therefore, **I, Varunjeet Charak, JKAS, Additional District Magistrate, Ramban** by virtue of powers vested in me under Section 144 of Cr.PC do hereby order that there shall be complete ban on carrying of licensed arms w.e.f today i.e March 16, 2024 throughout District Ramban.

Any person, if found carrying licensed arms, for any purpose whatsoever, after the issuance of this order, shall be dealt under law, the weapon shall be seized and license shall be cancelled without further opportunity.

However, the security guards involved in escorting vehicles carrying cash to banks/ ATMs and Bank/ATM guards are exempted from this order.

Senior Superintendent of Police, Ramban shall ensure the compliance of this order through concerned SHOs.

This order shall remain in force for a period of two months from the date of its issue.

Sub:- Implementation of Arms Act, 1959, Arms (Amendment) Act 2019 & Rules thereunder- regarding

ORDER

Whereas, vide Arms Amendment Act, 2019 dated 13-12-2019, in section 3(2) for the words "three firearms" the words "two firearms" have been substituted. The amended provision of subsection 2 of section 3 is reproduced as under:-
"Provided that a person who has in his possession more firearms than two at the commencement of the Arms (Amendment) Act, 2019 may retain with him any two of such firearms and shall deposit, within one year from such commencement, the remaining firearm with the officer in charge of the nearest police station or, subject to the conditions prescribed for the purposes of sub-section(1) of section 21, with a licensed dealer or, where such person is a member of the armed forces of the Union, in a unit armory referred to in that sub-section after which it shall be delicensed within ninety days from the date of expiry of aforesaid one year" and

Whereas, holding of more than two firearms at a time by any licensee is illegal as per the aforementioned provisions of the Arms Amendment Act, 2019; and

Whereas, vide this office order No. DM/Rsl/JC/2022-23/4402-12 dated 18-11-2022 & No. DM/Rsl/JC/2022-23/4279-92 dated 08-11-2023 the Arms Licensees of District Reasi were informed to retain two of such firearms and must deposit the additional firearm(s) at the nearest Police Station.; and

Whereas, the arms possessed by the licensees whose Arms Licenses are not uploaded on NDAL portal or are without UIN or issued by any authority who is not declared competent under the Arms Act, 1959 are required to be deposited in the nearby police station.

In view of above, it is hereby ordered that arms license holders who are either in possession of more than two fire arms or whose licenses have ceased to be legal on account of any of the above mentioned reasons are **now through the medium of this order given a final opportunity to deposit their weapons in the nearest Police Stations within a period of 30 days positively.**

Since, it is not possible to serve prior notice of this order, it is as such being issued ex-parte. Any violation of this order shall invite punitive action under section 188 of Indian Penal Code.

Senior Superintendent of Police Reasi shall implement this order in letter & spirit.
