

DEO takes onsite stock of election preparedness, facilities

SRINAGAR: The District Election Officer (DEO) Srinagar, Dr. Bilal Mohi-Ud-Din Bhat on Wednesday conducted comprehensive inspection of proposed election Strong Rooms cum Collection/ Distribution Centres for all 08 Assembly constituencies of Srinagar District.

The inspection was undertaken to assess the preparedness for smooth conduct of the upcoming Lok Sabha Election-2024 in the

District.

During the visit, the DEO/DC took onsite review of the arrangements and facilities at Strong Room cum Collection/ Distribution Centres for all 08 Assembly Constituencies viz 19-Hazratbal, 20-Khanyar, 21-Habbakadal, 22-LalChowk, 23-Chanapora, 24-Zadibal, 25-Eidgah and 26-Central Shalteng.

During the inspection, the DEO stressed upon the concerned Assistant Returning Officers (AROs) to take up

necessary measures to ensure that all required arrangements are put in place well in advance to facilitate smooth and efficient election process.

He asked them to make proper arrangements for polling staff, adequate parking and separate entry/exit of the vehicles carrying election material at Strong Rooms cum Collection/Distribution Centres.

He also laid emphasis on placing adequate spaces for counters to be placed at

Collection/Distribution Centres in order to avoid any cluttering during distribution/ collection of election materials.

While interacting with the AROs and other concerned staff, the DEO/DC underscored the importance of ensuring that all Strong Rooms cum Collection/ Distribution Centres adhere to prescribed standards of Election Commission of India to uphold the integrity and fairness of the electoral process.

He stressed on proper handling/ management of election material besides ensuring efficient and secure mechanisms for its storage.

Additional Deputy Commissioner (ARO/ERO-Zadibal), Dr. Khalid Hussain Malik, Additional Deputy Commissioner (ARO/ERO-Hazratbal), Syed Ahmad Kataria, Deputy District Election Officer, Mir Intiyaz Ul Aziz, Other AROs, and other concerned officers accompanied the DEO during the visit.

Election training for Zonal, Sector Magistrates held

BANDIPORA: In preparation for the upcoming Lok Sabha elections, a training programme was on Wednesday conducted for Zonal and Sector Magistrates of 15-Bandipora Assembly Constituency at Mini Secretariat, Bandipora.

The training programme was presided over by District Election Officer Shakeel ul Rehman and was attended by ARO/ACR Shabir Ahmad Wani, GM DIC, Zonal and Sector Magistrates of 15-Bandipora assembly constituency and other concerned.

The training was aimed to equip zonal and sector magistrates with the necessary knowledge and skills to ensure the smooth conduct of electoral processes and uphold the integrity of elections.

The zonal/sectoral Magistrates were briefed on their roles and responsibilities, emphasizing the importance of maintaining impartiality in carrying out duties for conducting peaceful and smooth elections.

On the occasion, DEO emphasized proper training of zonal and sector Magistrates and asked ARO 15-Bandipora to take review

from zonal and sector magistrates weekly besides directing the Zonal and Sector Magistrates to ensure assured minimum facility and all other necessary facilities at polling stations.

ARO 15-Bandipora Shabir Ahmad Wani on the occasion highlighted the role and responsibilities of zonal and sector magistrates.

He said magistrates are responsible for election management from the day of appointment till the com-

pletion of poll process and asked them to ensure effective implementation of communication plan and assured minimum facilities at each polling station including provision of ramp, drinking water, signages etc.

He also deliberated on pre-poll and poll day responsibilities of Zonal and sector magistrates.

The ARO also emphasized the importance of ethical conduct and adherence to code of conduct for electoral officials.

BANDIPORA: District Election Officer (Deputy Commissioner) Bandipora, Shakeel-ul-Rehman on Wednesday asked the political parties and contesting candidates to desist from intimidating or bribing the voters and urged them to strictly follow the Model Code of Conduct.

Through a general public notice, DEO brought to the notice of General Public, Contesting Candidates and Political parties that violation(s) of Mode Code of Conduct including public intimidation, threats, influences and bribery of electors like distribution of cash/liquor etc., are offence(s) under section 171B IPC and corrupt practices under section 123 of Representation of People Act, 1951. The DEO informed the general public that Complaint(s), if any, in case of such violations, can be lodged with the Complaint Monitoring Cell established in office of the District Election Officer, Bandipora on Toll Free No 1950 or Complaint Monitoring Centre Mini Secretariat Bandipora on 01957-225322.

Besides, e-VIGIL mobile App can also be downloaded to register such complaints through online mode.
