"This is India which will not be pressured, which will state its mind. If it has to make we will make a choice for the welfare of our citizens So, the idea is of much stronger, more capa ole India and willing to take the tough course," he said.

Jaishankar assured that this is an India which looks after its citizens and people of Indian

"As more and more Indians settle in different parts of the world, it is our responsibility to secure them, to ensure their wellbeing if they are in a difficult stage, to bring them home," he said. Ukraine and Sudan were cited as examples of where Indians were caught between the

"The capable India, the diplomatic India, the reformed India, the protective India in many vays the innovative India," he stressed, pointing to the global respect won by the Chandrayan
