CRIMEREPORT

Bovine smuggling bid foiled; 9 bovines rescued, vehicle seized

SAMBHA: Samba on Tuesday foiled bovine smuggling attempt in early morning hours in the jurisdiction of Police Station Ghagwal, rescued nine bovines and seized vehicle used in the illegal transportation of bovines.

A Police team of Police Station Ghagwal headed by SHO Police Station Ghagwal special naka has been established at Rajpurawhile performing vehicle checking duty in jurisdiction area, signalled to stop a dumper bearing registration number JK21A-6297 coming from Kathua side via border road for checking. During checking of the vehicle, nine bovines were found laden inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. A case FIR No. 29/2024 u/s 188IPC, 11 PCA Act, has been registered at Police Station Ghagwal and investigation started.

4 drug peddlers arrested, contraband substances recovered

PULWAMA: Continuing its unwavering efforts to eradicate the menace of drugs from the society, Police on Tuesday arrested two drug peddlers in Kulgam & Pulwama and recovered contraband substances from their possession.

A police party of Police Station Qazigund during patrolling at Village Berigam intercepted a suspicious person carrying a polythene bag, who tried to flee after noticing police party, but was apprehended tactfully. During search, officers were able to recover 85 grams of charas like substance from his possession. He has been identified as Mohd Amin Dar son of Abdul Ahad Dar a resident of Berigam. He has been arrested and shifted to police station where he remains in custody.

In Pulwama, acting on specific information regarding hoarding of contraband substance by one person namely Mohd Ayoub Rather son of Gh Mohd Rather resident of Fraspura Pulwama at his house. Acting swiftly, police raided the said house and recovered 10.4Kgs of Charas powder like substance and arrested the said accused person on the spot.

Accordingly, cases under relevant sections of law have been registered in respective police stations and investigation have been initiated.

Police also arrested two drug peddlers in Baramulla and recovered contraband substances from their possession.

A police party of Police Post Wussan headed by IC PP Wussan at a checkpoint established at Wussan Chowk, intercepted a vehicle (Auto) bearing registration number JK01P-4705 with two persons on board. During search, 2.15Kgs of Poppy Straw like substances were recovered from their possession. They have been identified as Sahil Ahmad Sheikh son of Ghulam Mohammad resident of Sher Colony Sopore &

Mudasir Ahmad Dar son of Ab Aziz resident of Jalalabad Sopore. They have been arrested and shifted to PS Pattan where they remain in custody. Vehicle used in the commission of crime has also been seized. Accordingly, a case under relevant sections of law has been registered at Police Station Pattan and investigation have been initiated.

Theft case solved; accused arrested, stolen property, mobiles recovered

REASI: Police on Tuesday solved a theft case by nabbing a thief and recovered stolen property and 4 mobile phones.

On the basis of complaint received from a pilgrim Atharv Sulakhiya, son of Santosh Kumar Sulakhiya, resident of Chorai, Chhindwara, Madhya Pradesh at Police Station Bhawan that unknown person has stolen 04 mobiles along with the other items worth Rs 160,597/-.

In this regard, Case FIR no. 02/2024 under section 379 IPC was registered and investigation started by Police Station Bhawan. A team led by Khyatimaan Khajuria SHO Police Station Bhawan immediately rounded up many suspects and finally successfully recovered 4 mobiles and stolen property worth Rs. 160,597 from accused person namely Rahul Singh, son of Subash Singhm, resident of Pakhlai, Udhampur along with stolen property worth Rs. 160597 who was arrested in the instant case. His interrogation for his involvement in other cases of similar nature is going on.
