"It's going to be a very hard thing to do business like this," Trump told Zelenskyy at one point, as the two leaders talked over each other about past international support for

"Again, just say thank you," Vance interjected to Zelenskyy, blasting him for litigating disagreements" in front of the press. Trump, though, suggested he was fine with the drama. "I think it's good for the American people to see what's going on," he added. "You're not acting at all thankful," Trump said, before adding, "This is going to be great

The harsh words came at a pivotal and precarious moment for Ukraine. Zelenskyy had

planned to try to convince the White House to provide some form of US backing for Ukraine's security against any future Russian aggression. Zelenskyy is still expected to sign a landmark economic agreement with the US aimed

at financing the reconstruction of war-damaged Ukraine, a deal that would closely tie the o countries together for years to come The deal, which is seen as a step toward ending the three-year war, references the

mportance of Ukraine's security. Earlier in the meeting, before tempers flared, Trump said the agreement would be signed soon in the East Room of the White House. "We have something that is a very fair deal," Trump said, adding, "It is a big commit-

ment from the United States.

He said the US wants to see the killing in the war stopped, adding that US money for Jkraine should be "put to different kinds of use like rebuilding."

Earlier, Zelenskyy called Russian President Vladimir Putin a terrorist and told Trump that Ukraine and the world need "no compromises with a killer." "Even during the war there are rules," he said.

As Ukrainian forces hold out against slow but steady advances by Russia's larger and

better-equipped army, leaders in Kyiv have pushed to ensure a potential US-brokered peace plan would include guarantees for the country's future security. Many Ukrainians fear that a hastily negotiated peace - especially one that makes too

many concessions to Russian demands - would allow Moscow to rearm and consolidate ts forces for a future invasion after current hostilities cease.

The seizure will cut off a potential source of terror funding that would have been used to revive Hizbul Mujahideen's influence in the region, he added.

Police said the families of the five terrorists will now face legal and financial constraints, preventing them from providing indirect support to militant activities.

The Jammu and Kashmir administration has been proactively cracking down on terror funding, overground worker (OGW) networks and exfiltrated terrorists, significantly weakening the terror ecosystem in recent years, the spokesman said.

The latest action aligns with the government's zero-tolerance policy towards terrorism,

The weather is likely to improve from Friday afternoon, according to the weather office. The inclement weather affected traffic on the Srinagar-Jammu national highway, and

Court rejects bail of Bank Manger in multi-crore loan scam

JAMMU: Special Judge Anticorruption Jammu Haq Nawaz Zargar rejected the bail application of Jatinder Singh Branch Manager who was arrested by the Crime Branch in multicrore loan scam.

Special Judge Haq Nawaz Zargar, after hearing APP Mohd Amir-al-Mansoor for the Crime Branch, observed that if the applicant is released on bail now, it is likely to prejudice the investigation which is being carried out. It is not possible for the court to monitor the sources of communication of the accused and to control his conversations with other co-accused particularly Mohd. Safeer who is absconding, so as to prevent the tampering with the evidence

The huge trail of money and its recovery is yet to be established. Some more arrest are likely to be made in future as investigating agency had already brought in the notice of this court that the sanction under section 17-A of the Prevention of Corruption Act had already been obtained viz-a-viz other bank employees also who had served In the concerned branches.

Obviously, exercising the power of discretion for grant of bail in favour of the accused/applicant at this stage would prejudice the Investigation, thereby it not on!/ makes such white collared criminals emboldened but rendered this Investigation a futile exercise. Since, the investigation is going on to bring to surface the larger conspiracy and the Involvement of some more bank officials is likely to surface in coming days and In such circumstances, the present accused do not deserve the concession of bail. Court do not find any merit in the contention of the learned counsel for the applicant that he is not in a position to influence the witnesses

The involvement of the other accused/ bank employees and also the beneficiaries of the transactions is being examined. The accused, If released on bail at this stage, can surely tip off his associates and the beneficiaries who were allegedly In contact with him and try to influence them.

While rejecting bail application, Special Judge Anticorruption Jammu Haq Nawaz Zargar observed that the banking system in India has its great significance particularly for the middle and lower strata of the society. The deposits with the bank are the trust which comes out of the hard earned money from the pockets of the common man.

The bank officials owe a divine duty to uphold that trust and invest the same adequately and properly, so that the depositors will get their due in time. If the banking officials started eating the very vital of the deposits, than its not possible to run the economy of the state smoothly.

The corrupt approach on ' behalf of the bank officials can't be tolerated at any stage, as it is a direct threat to the economy of the country, which demands a zero tolerance approach to such culprits.

The allegations point towards a systematic siphoning off of bank money by the accused with connivance of other accused persons. The trust which is reposed by the bank on its employee particularly accused that he would take care of the money of the bank and of its depositors stands breached. No doubt, the court has to balance between the individual liberty and the societal interest, but showing leniency in such matters by the courts amounts to doing disservice to the society and public interest in my opinion would not be served.

Before parting with this application in hand, Court would like to bring it to the notice of IGP Crime UT of J and K, that In economic offences/scams usually lengthy Investigations is a normal affair and is not only a test of investigating prowess but also his/her test of patience. So proper care must be taken while constituting a SIT and its member or appointing an IO.

Court seeks ATR from SHO Billawar in Makhan Din's Custodial Torture

JAMMU: In a significant development, the Sub-Judge/Special Mobile Magistrate, Kathua Amandeep Kour has directed SHO, Police Station Billawar to submit Action Taken Report (ATR) in two complaints seeking registration of FIR in the custodial torture of Makhan Din, son of Mohd Mureed, resident of Village Bhatodi, Tehsil Billawar, District Kathua.

One complaint has been filed by Father of the deceased Makhan Din (Mohd Mureed) and widow of Makhan Din namely Juna Begum and second complaint has been filed by Advocates Mohd Anwar Chowdhary and Sheikh Shakeel Ahmed. Both complaints have been filed through Advocate Appu Singh Salathia.

When these two complaints came up for hearing before Sub-Judge/Special Mobile Magistrate, Kathua Amandeep Kour, Advocate Appu Singh Salathia appearing for the complainants submitted that despite approaching SHO, Police Station Billawar and SSP, Kathua, the FIR into the custodial torture of Makhan Din was not registered even though prima facie cognizable offences are made out against the accused and this compelled the complainants to invoke the jurisdiction of this Court under Section 175(3) BNSS, 2023.

Advocate Appu Singh Salathia submitted that 26 years old tribal boy-Makhan Din alongwith his father Mohd Mureed were subjected to third degree torture while they were in custody of Billawar Police. She further submitted that on February 4th, 2025 two police officials namely Mohd Shafi and Lucky on the directions of their senior officers throughout the night tortured Makhan Din and his father Mohd Mureed in order to compel them to make statements for having links with the militants/subversive activities.

During the course of hearing, Advocate Appu Singh Salathia referred celebrated judgement of Supreme court regarding Custodial Torture/police excesses titled DK Basu V/s State of West Bengal and Ors. wherein the Apex Court has laid down more than ten guidelines to be followed by the police officers while making arrest or custodial interrogation.

Advocate Appu Singh Salathia further submitted that recently a Bench of the Apex Court comprising Justices Vikram Nath and Ahsan-Ud-Din Amanullah expressed displeasure with the conduct of the Investigative Agencies and the police for not adhering to the constitutional and statutory safeguards while arresting and taking the accused into custody.

The said Bench further observed, _"It is sad that even today, this court is forced to restate the principles and directions in DK Basu's case."_ Advocate Appu Singh Salathia also referred to the Constitutional Bench Judgement titled Lalita Kumari V/s State of UP and Ors, wherein the Five Judge-Bench of the Apex Court ruled that when a complaint discloses commission of a cognizable offence. the FIR has to be mandatorily registered and in the present case, the Billawar Police has violated the Judgement of the Supreme Court with impunity.

Advocate Appu Singh Salathia further submitted that the video deposition of Makhan Din was sufficient for the registration of the FIR but despite his dving declaration, the Billawar Police miserably failed to register the case and under these circumstances the present two complaints have been filed.

She further prayed before the Court that this is a fit case for issuing directions to the Billawar Police to register FIR in the matter as prima facie commission of cognizable offences are made out.

After considering the detailed arguments of Advocate Appu Singh Salathia, the Sub-Judge/Special Mobile Magistrate, Kathua Amandeep Kour directed SHO, Police Station, Billawar to file Action Taken Report in the matter before the next date of hearing i.e. March 4th, 2025.
