Whereas, the Jammu and Kashmir Services Selection Board vide notification No. JKSSB-COE0EXAM(UT)/10/2024 issued the Result/Scoresheet of the candidates who appeared in the OMR Based Written Examinations held on 01-09-2024 for the post of Patwari (Revenue Department) District Cadres, advertised vide Advertisement Notification No. 02 of 2021 under item Nos. 455, 458, 464, 468, 471, 475; and

Whereas, the Jammu and Kashmir Services Selection Board vide No. JKSSB-COE0EXAM(UT)/10/2024-03 (7434645) issued Document Verification Notification for candidates falling under consideration zone for the post of Patwari (Revenue department), District Cadres, advertised vide Advertisement Notification No. 02 of 2021 under item Nos. 455, 458, 464, 468, 471, 475, wherein candidates were called to appear in person before the designated Document Verification Committees of the Board for verification/scrutiny of their documents/certificates; and

Whereas, one candidate namely Jamal Arif Para S/o Ab. Rashid Para R/o 59 Para Mohalla Homehuna Chitragam, Shopian, 192303 was also called to appear before the designated Document Verification Committee under D.V S. Whereas, the said candidate appeared before Document Verification Committee on 16.10.2024 and submitted copy of application form which depicted/showed six item Nos while as the record provided to the Document Verification Committee showed that he had applied only for one item No. i.e. Shopian 468. The Document Verification Committee accepted his documents at the time of Document Verification subject to the verification of item numbers the candidate has applied for, as the document verification data provided to the Committee showed only one item No i.e. 468 (Shopian); and

Whereas, the Selection Committee constituted for the post of Patwari (Revenue Department), found/observed that the online application form submitted by the candidate shows that he has applied only for item No. 468 District Shopian and the copy of application form submitted by the candidate at the time of document verification seems to be tampered/forged; as such recommended that the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, under part XXX (67), may examine the case in detail; and

Whereas, a meeting of Unfair Means Committee was convened wherein it was decided to serve a show cause notice to said candidate to give him an opportunity of being heard in person or through an authorized counsel to explain his conduct/position, in the first instance, before proceeding further; and

Whereas, a show cause notice vide No. JKSSB-Scry/3/2025-06 dated 24-02-2025 was served to the said candidate. The reply to the said show cause notice was submitted by the said candidate on 28-02-2025; and

Whereas, the Unfair Means Committee analysed the response submitted by the candidate and discussed the case and after considering the nature of the offence and evidences brought on record, as also the reply of the candidate, recommended as under: -

**"The Committee observed that the said candidate has tampered/forged the application form submitted at the time of Document Verification. Therefore, the candidature of the candidate be cancelled ab-initio, besides the candidate be debarred for a period of 5 years for all examinations conducted by JKSSB w.e.f the date of conduct of said examination i.e. 01-09-2024. The Committee further recommends that the Board may take any other legal action against the said candidate, if deemed appropriate."**

Whereas, the recommendation of the Committee was placed before the Board in its 300<sup>th</sup> Meeting held on 06.03.2025, which accepted the recommendations of the Unfair Means Committee.

Therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of the candidate namely Jamal Arif Para S/o Ab. Rashid Para R/o 59 Para Mohalla Homehuna Chitragam, Shopian, 192303 for the post of Patwari (Revenue Department) advertised under Notification No. 02 of 2021 dated 26-03-2021 is hereby cancelled.
