TRAFFIC POLICE ADVISORY DURING THE CLOSURE OF ROAD STRETCH FROM SATWARI TO LAST MORH GANDHI NAGAR W.E.F. 11.03.2025.

As intimated by Project Director NHAI, PIU- Jammu vide letter no. PD/JMU/DKE/Pkg-16/2024-25/360 Dated: - 06.03.2025, the construction work of flyover from Satwari Chowk to last Morh Gandhi Nagar will be undertaken by the concerned executing agency w.e.f. 11.03.2025. In this regard, the tube coming from Satwari Chowk towards Last Morh Gandhi Nagar shall remain restricted for the movement of General Traffic during the said construction work. Hence for ensuring hassle free movement of traffic, the following traffic diversions are hereby placed on ground: -

DIVERSIONS: -

- All interstate vehicles coming from Samba/ Kathua via Kunjwani, Gangyal bound for Jammu City shall be diverted from Satwari Chowk towards MH Hospital Road - Beli Charana - 4th Tawi Bridge - Asia Crossing / Canal Head and further towards their destination.
- All kinds of vehicles coming from R.S Pura, Miran Sahib and adjoining areas bound for Jammu City shall be diverted from Satwari Chowk towards MH Hospital Road - Beli Charana - 4th Tawi Bridge - Asia Crossing/ Canal Head and further towards their destination.
- The traffic plying on the road stretch from Bikram Chowk upto Satwari Chowk shall remain through for one way traffic movement however the traffic plying will be diverted from last Morth Gandhi Nagar in the Right Tube towards Satwari Chowk.
- The traffic coming from 4th Tawi Bridge bound for Satwari side shall not ply via Beli Charana rather shall be diverted to Ware House - Asia Crossing - Last Morh Gandhi Nagar and towards Satwari Chowk.

General Public is requested to cooperate with District Administration and Police so that better traffic management can be maintained.

PUBLIC NOTICE

- Section 7 of Foreigners Act 1946, outlines that online Form C is a mandatory form that needs to be filled up for all foreigners by Hotel keepers, Home stays, Guest Houses and others, on government site indianfro.gov.in/ boi.gov.in. Moreover, non-conformity to the above directions can attract imprisonment for a term which may extend to 5 years and shall also be liable to fine- under section 14 of Foreigner's Act 1946.
- Hotels/Lodges/Home stays/individual houses/ universities/Hospital/Hostels/ institutions and others who provide accommodation to foreigners must submit the details of the residing foreigner in Form C to the Registration authorities within 24 hours of the arrival of the foreigner at their premises. This will help the registration authorities in locating and tracking the foreigners.
- Form-C must include the following details of the visiting foreigner guests:
 - Arrival and departure date.
 - Photo ID proof of all the foreigners.
 - Detail of Valid travel documents which includes valid Passport and Visa.
 - Purpose of visit (to be added under remarks column).
 - Name of Indian reference with mobile number.
 - Further tour programme with next destinations to be visited.
- Any person hosting a foreign guest for monetary consideration is required to submit form C. This also includes Foreigners on Tourist visa, Business visa, Visiting visa, Employment visa, Medical visa, conference visa, project visa, intern visa, research visa, Journalist visa etc.
- The Host shall maintain separate Visitors Registers mentioning correct arrival/departure dates and timing of the foreigner.
- In case of any suspicion or default on the part of Foreigners checked in to your respective Hotels, Lodges, Home Stays and Guest Houses etc. inform immediately to CID SB Jammu Control Room telephone Nos. 0191-2584375, 0191-2582621, 6005504514, 8825097826.

Through the medium of this Public Notice, the general public/ motorists are hereby informed that on **16.03.2025 (Sunday)** at 06:30 AM "Run for Fun Jammu Marathon" will be organized by J&K Police. In this connection the following diversions will be applicable on 16.03.2025 from 0500 Hours to till conclusion of Marathon (11:00 AM expectedly).

MARATHON ROUTE: -

Gulshan Ground (Starting/ Finishing Point) - PHQ Main Gate - P/S Bagh-e-Bahu Crossing - Qasim Nagar - NH-44 - Forest Check Post - Environment Park - Hill View Honda near Bajalta Crossing.

DIVERSIONS: -

- All kind of traffic movement shall remain restricted on the marathon route during the movement of Marathon participants.
- All kind of vehicles from City South bound for Bagh-e-Bahu/ Bawe Temple shall be diverted from Bikram Chowk towards Dogra Chowk and shall follow the route from Dogra Chowk - Fortune Rivera Cut - Maharaja Hari Singh Park - Gujjar Nagar Bridge - Bawe Temple during Jammu Marathon.
- Vehicles coming from Gujjar Nagar bound for Bikram Chowk shall be diverted from Gujjar Nagar Bridge towards Dogra chowk via Vivekananda Chowk for their destination.

- All vehicles coming from Samba/ Kathua bound for Nagrota shall be diverted towards Satwari Chowk from Kunjwani Chowk towards Nagrota via Bikram Chowk - Vigilance Rotary - Manda.
- All vehicles coming from Kunjwani, Greater Kailash, Chowadhi, Channi Himmat shall be diverted at Narwal towards RTO Cut/ Railway Crossing/ B.R Ambedkar Chowk.
