Whereas, the appropriate Government is satisfied that there are sufficient reasons for acquisition of land measuring 06 marla situated at village Jib, Tehsil and District Udhampur for construction of 30000 glns GSR under WSS ;

Whereas, on the basis of indent placed by Chief Engineer, Jal Shakti (PHE) Department, Jammu vide No. PHEJ/Plg/129-A/2022-23 dated 08-07-2022 and after the approval of appropriate Government, Collector Land Acquisition, (Assistant Commissioner Revenue) Udhampur constituted a committee vide No. ACRU/LA/2023-24/604-17 dated 07-03-2024 for conduct of Preliminary Enquiry under the chairmanship of Tehsildar Udhampur for the acquisition of aforesaid land. The committee so constituted submitted report vide No TUDR/OQ/2023-24/3431 dated 11-03-2024 & further reported that no involuntary displacement of persons and neither any adverse impact is caused nor any rehabilitation is required due to acquisition of aforesaid land;

Whereas, Collector Land Acquisition, (Assistant Commissioner Revenue) Udhampur vide No ACRU/NSQ/LA/2024-25/768-76 dated 26-11-2024 issued notification under Section 11 (1) of "Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013", for the land measuring 06 marla situated at village Jib, Tehsil and District Udhampur. The Collector got published the said notification in the local dailies/leading newspapers and a copy of same was also sent to Tehsildar Udhampur to file the objections, if any, within 60 days from the date of publication of the same in the office of Collector.

Whereas, no objections were received within stipulated time, the Collector has provided opportunity of being heard to all the objectors as required under section 15(2) of the said Act and has conducted further enquiry and submitted the report for taking decision;

Whereas, Collector Land Acquisition, (Assistant Commissioner Revenue) Udhampur has requested for issuance of declaration under section 19 (1) of the said Act, for the land measuring 06 marla situated at village Jib, Tehsil and District Udhampur.
