Subject: - **Final Show Cause Notice.**

➤ Whereas, you Sgt. Mohd Tahir Belt No.1222/J, PID No. EXJ005966 S/O Sh. Mohd Hussain R/O Banola, Tehsil Mendhar, District Poonch was found absent unauthorizedly from duty vide DDR No.09 dated 09.05.2023 while your posting in DPL Jammu.

➤ Whereas, you remained continuously absent from duty and vide **DPO Jammu's OB. No.698 of 2023 dated 15.09.2023** you were placed under suspension on account of your prolonged absence, besides a departmental enquiry was initiated against you and entrusted to SDPO Nagrota.

➤ Whereas, SDPO Nagrota, Jammu (Enquiry Officer) has made correspondences on your part vide his office signal Nos. Rdr/DE-23/2023/543/SDN dated 24.01.2024 and Rdr/DE-23/2245/SDN dated 28.03.2024 through Dy.SP DAR Jammu to attend the office of Enquiry Officer for facing Departmental Enquiry but you did not bother to attend the office of Enquiry Officer.

➤ Whereas, Dy.SP DAR DPL Jammu vide signal Nos. DAR /Absent/ 24/ 433 dated 29.01.2024 and No. DAR/DE/24/2399 dated 30.03.2024, intimated that you are continuously running absent from duty w.e.f. 09.05.2023.

➤ Whereas, DPO Jammu vide signal No. Estt/CRC/24/93701-02/DPOJ dated 29.10.2024 and No. Estt/CRC/25/3802-03/DPOJ dated 14.01.2025 directed you through SHO concerned to resume your duties but you did not bother to report back on duty.

➤ Whereas, Enquiry Officer also served a notice to you vide No. 124-26/ SDN dated 04.01.2025 through SHO P/S Mendhar which got noted from your brother under proper receipt and even then you did not bother to resume your duty.

➤ Whereas, you being a member of Police force is not joining your duty despite making multiple correspondences on your posting as well as home address which clearly amounts to indiscipline, carelessness, dereliction of duty and violation of Police Rule.

➤ Enquiry Officer after conducting enquiry, into the matter came to the conclusion that delinquent official Sgt. Mohd Tahir, No. 1222/J PID No. EXJ005966 is continuously running unauthorized absent from duty for a long time which shows he is not interested to serve more in the department.

➤ Whereas, being a member of discipline force you should have to inform senior formations for any kind of grievance being faced by you but you failed to do so and so much so you also did not bother to appear before the enquiry officer for facing the enquiry. Accordingly, E/O constrained to take exparte decision and recommended that Sgt. Mohd Tahir No. 1222/J PID No. EXJ005966 may kindly be dismissed from the services of Police department.

➤ Whereas, there is also another departmental enquiry was initiated against you vide DPO Jammu order No. 425 of 2023 dated 08.06.2023 on account of your involvement in case **FIR No. 51 of 2023 U/S 420/467/468/IPC P/S Gandhi Nagar** and is still under enquiry with SDPO City South Jammu.


➤ Whereas, SHO Police Station, Bus Stand Jammu vide signal dated 18.02.2025 also intimated that a case **FIR No. 15 of 2025 U/S 318(4)/336(3)/340(2)/BNS** has also been registered against you at **P/S Bus Stand**

Now through the medium of this notice, I, Joginder Singh, JKPS, SSP Jammu direct you Sgt. Mohd Tahir Belt No. 1222/J, EXJ005966 S/O Mohd Hussain R/O Banola P/S Mendhar Tehsil Mendhar, District Poonch to show cause as to why you should not be **removed from the department w.e.f the date of your absence** for not joining the duty since long and involvement in different FIRs.

Your reply should reach to this Hqrs. within seven days positively from the date of issuance of this notice, failing which it shall be presumed that you have nothing to say in your defence and an exparte decision as envisaged under rules referred above will be taken against you.
