J&K Bhagat Welfare Forum opposes changes in SC Reservation Policy

KISHTWAR: Ajeet Bhagat, Convener of the Jammu and Kashmir Bhagat Welfare Forum, has strongly opposed the recent review of the reservation policy for the Scheduled Caste (SC) community by the J&K Government, calling it a direct attack on their rights. Bhagat emphasized that any attempt to dilute the reservation system is unacceptable. "These policies are not just about numbers; they are about our identity, progress, and justice. If the government moves forward with plans to merge categories and reduce quotas further, it will push our community into an era of inequality and oppression," he stated. Condemning the changes in the strongest terms, he highlighted how the SC community has historically faced marginalization, and such policies only add to their struggles. He urged the authorities to take immediate action to protect the constitutional rights of the community. "This is the time to stand united. Let's raise our voices on every platform and let the world know that we will not accept this injustice," Bhagat asserted. He further demanded an increase in the reservation quota for the Scheduled Caste (SC) community in employment from 8% to 27%, in line with policies adopted by other states.

Now therefore, in light of contents of foregoing paras, the applications of all the above applicants whose credentials have been disowned by the said competent authority are hereby rejected ab-initio.
