

2 medical shops put on show cause notice, operation of 1 disallowed

SHOPIAN: A team of officials from the Drugs Control department on Wednesday conducted inspection of medical shops in various villages of Shopian district including Kundalan Nagisharan, Hajipora, Chakoor, Dangan and Kaprin. The team headed by Assistant Drugs Controller Shopian put two medical shops on show cause notice, and the operation of one medical shop was disallowed on the spot at Kundalan for non maintenance of records of scheduled formulations and violations of other conditions of Licenses.

CCTV footage of the inspected firms were also checked by the team, and all shops were asked to adhere to the guidelines of dispensing of drugs.

In context to subject cited above and as reported by concerned Assistant Executive Engineer (Mech.) that the work allotted vide above referred Work order for WSS Bain Bajalta (E) under Jal Jeevan Mission (JJM) has not been started till date. After a lapse of more than 07 months approx; your firm has not submitted the Performance Security @ 3% of the work order amount as per clause No. 10 of Standard Bidding Document and the QAP/drawings of Pumping machinery has also not been submitted. This office has made various communications to your firm to get the drawings approved and start the works allotted at site. Moreover, a letter via e-mail dated: 30.01.2025 was also written to your firm for submission of Performance Guarantee (@3%) and Notice was also issued in favour of your firm for non-compliance of contractual stipulation, but nothing has been heard from your side till date.

As such, through the medium of this final notice, you are again directed to submit the Performance Security and QAP's / drawings for approval within three days (03) and expedite the work and get it completed within stipulated time period as given in the work order, failing which your contract shall be terminated as per Clause No. 34 of Standard Bidding Document mentioning that "The Department reserves the right to cancel the order in case of fault on the part of the contracting agency and also prior to the receipt of the intimation regarding taking in hand execution of work against the order. No claim, whatsoever, shall be tenable against the department on this account."

Since time of completion was due essence of tender, delay in completion has been viewed seriously by the higher authorities, inviting stern action in case of any further deviation in the matter, the work Been time bound as JJM is a target based project.

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K re-organization Act, 2019 ;

Whereas, the staff dealing with applications uploaded through online portal informed that there is some evident suspicion about the credentials of applicants who claim to acquired requisite eligibility from Veer Bahadur Singh Purvanchal University, Jaunpur, U.P

Whereas, the above inputs were taken on record and a confidential exercise was initiated with the competent authority of Veer Bahadur Singh Purvanchal University, Jaunpur, U.P through Email along with all the documents uploaded as per checklist;

Whereas, in response to the above mail a return mail/communication from Head, Institute of Pharmacy, VBSPU, Jaunpur, U.P was received, vide letter no: MEMO/Verf/2025, Dated: 20.02.2025, the operative para of which is reproduced as under:

"Thank you for your communication dated 18/02/2025 regarding the verification of candidates applying for registration as pharmacists from the Union Territory of Jammu & Kashmir. After thoroughly reviewing our records, we would like to inform you that, to date, no candidate from the Union Territory of Jammu & Kashmir has either been admitted to or has passed the B. Pharm or D. Pharm programs at our institution. As such, we do not have any relevant records to submit in response to your request".

Whereas, the response highlighted herein above clearly indicates that the claims of eligibility by the applicant are not bonafide & further the said person has indulged in unfair means;

Whereas, at the time of filing the application through online portal, the applicant has also submitted E-undertaking with one of the below averments:

"That I am fully aware that in the event of any of my document found invalid, fake or false as also for any concealment or misrepresentation of facts stated herein, the J&K Pharmacy Council has the power to delete/reject my candidature as Registered Pharmacist without any formal notice or information".

Whereas, the above person was offered an opportunity to provide his response in the matter through show cause notice vide this office letter bearing no: JKPC/SCN/2025/PHAR006944-Estt-1011-1024, Dated: 21.02.2025;

Whereas, till date no reply was received from the applicants end;

Whereas, the applicant has failed to respond to the communications reflected in para supras and therefore the applicant has not availed of his right to be heard before a decision in the matter is taken.

Now, therefore the undersigned in exercise of powers vested under Section (36) of the Pharmacy Act, 1948 rejects the application of the applicant for registration as Pharmacist in terms of Section 32 of the Pharmacy Act, 1948 and the name of the applicant is hereby removed from the register maintained by the J&K Pharmacy Council with immediate effect.
