Samba Police foils bovine smuggling attempt, rescues three bovines

SAMBA: Continuing its drive against bovine smuggling, Samba Police foiled an attempt to illegally transport bovines in the jurisdiction of Police Station Ghagwal, rescuing three bovines and seizing the vehicle involved in the offence.
According to police officials, acting on specific information, a team from Police Station Ghagwal was conducting vehicle checking at Naka NHW Tappal when they intercepted a Mahindra load carrier bearing registration number JK12A-7477 for inspection.
During the checking, police found three bovines tied in a cruel manner inside the vehicle, which were being transported without any valid permission. The police team immediately rescued the animals and seized the vehicle used for the illegal transportation.

In this connection, a case FIR No. 26/2026 has been registered at Police Station Ghagwal under Section 223 of the Bharatiya Nyaya Sanhita (BNS) and Section 11 of the Prevention of Cruelty to Animals (PCA) Act.

Police said further investigation into the matter has been initiated to identify and take action against those involved in the smuggling attempt.

Six held as Jammu Police Bust Gambling Racket in RS Pura

JAMMU: Jammu Police launched a decisive crackdown on illegal gambling, arresting six persons during a swift raid conducted by Police Station RS Pura in the RS Pura area.

Acting on specific intelligence inputs, a police team carried out a well-coordinated operation at village Seer Balah on March 8 and caught six individuals red-handed while indulging in unlawful gambling activities. The accused were immediately taken into custody.

The arrested persons have been identified as Ashok Kumar, son of Sardari Lal, resident of Chak Bakhtawar, Tehsil RS Pura; Gurmeet Singh, son of Hardeep Singh, resident of Chak Mohd Yar, RS Pura; Lekh Raj, son of Bua Dutta, resident of Chak Mohd Yar, RS Pura; Deep Singh, son of Gian Chand, resident of Balah, Tehsil Suchetgarh; Bhopinder Singh, son of Rashpal, resident of Balah, Tehsil Suchetgarh; and Rashpal Singh, son of Anant Ram, resident of Balah, Tehsil Suchetgarh. All the accused have been booked under Section 13 of the Gambling Act. During the raid, police recovered ₹26,195 in cash along with two sets of playing cards from the spot. Officials said further investigation is underway to ascertain whether the accused have links with any larger gambling network operating in the region. The operation was led by PSI Affan Nazir under the close supervision of SFO RS Pura Inspector Tribhawan Khajuria, SDPO RS Pura and SP Headquarters Jammu.


