

Central Govt working with commitment for honour and justice of Sikh community: Modi

NAVI MUMBAI: Prime Minister Narendra Modi on Sunday said the Central government is working with full commitment for honour and justice of the Sikh community.

Modi virtually addressed the 'Hind-Di-Chadar' commemoration event held in Kharghar here to mark the 350th martyrdom anniversary of Guru Tegh Bahadur. "Our government is working with full commitment for honour and justice to the Sikh community," the Prime Minister said. Because of this commitment, the Union government formed an SIT for the 1984 riots, he pointed out. "Many cases related to the 1984 riots were closed. We reopened it, and the government also announced additional compensation to the riot-affected families. The National Commission for Minorities was given a more active role," Modi said. When issues relating to the safety and security of Sikh families and sacred copies of the Guru Granth Sahib arose in Afghanistan, the government acted in a mission mode, he said. "We are working in a mission mode. Our government safely brought back 'saropis' (Shri Guru Granth Sahib copies) from Afghanistan. Through CAA, we offered relief to the persecuted Sikhs," the PM asserted. Modi also said rehabilitation packages were implemented for Sikh families from Jammu and Kashmir, while OCI and visa regulations were simplified and thousands of blacklisted names of Sikhs were removed.

WHEREAS, the tentative seniority list of PG Masters/ PG Teachers in the discipline of Sanskrit was issued vide Notice dated 26.12.2025 for inviting objections, if any, from the members of the service;

AND WHEREAS, after the issuance of the tentative seniority list, the Department received objection from one cadre member namely Ms. Nisha Devi, (CRU-6406322) for inclusion of her service particulars in the seniority list;

AND WHEREAS, the objection received in the Department has been examined and it was observed that the incumbent instead of submitting her service particulars through the concerned Directorate is making direct representations to the Administrative Department and as such her plea cannot be considered till authenticated service particulars are received from the concerned Directorate;

AND WHEREAS, the Designated Committees have recommended 03 incumbents, (Annexure-B to this Government Order) in light of Government Order No. 188-JK (Edu) of 2024 dated 15.03.2024, who have obtained their PG degrees through distance/private mode during service. The recommendations made in their favour, after examination in the Department, have been accepted by the Competent Authority. These incumbents, some of whom already figured in the tentative seniority list on conditional basis, have now been incorporated in the final seniority list at appropriate places;

AND WHEREAS, some of the incumbents, who have obtained their PG degrees during service and whose cases have not yet been recommended by the Designated Committees constituted vide Government Order No. 188-JK(Edu) of 2024 dated 15.03.2024, have also been incorporated in the seniority list, with the condition that their inclusion in seniority is subject to the condition that proper permission has been/is granted by the Competent Authority for acquiring the PG degree during service. Their names shall be deemed to have been deleted from the seniority list, ab-initio, in case the recommendations are not received in the time frame decided in the ibid Government order.

Now, therefore, in terms of Rule 24 of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956, final seniority list of PG Masters/Teachers in the discipline of Sanskrit, forming "Annexure A" to this Government Order, is hereby issued.
