

DODA: Doda Police has successfully traced out a missing lady and reunited her with her family after completing all necessary legal formalities. On 02/03/2026, a report regarding the missing of a lady R/o Chmote Goha Marmat, under the jurisdiction of Police Station Doda, was received and subsequently entered at Police Post Goha Marmat vide DD No. 07 dated 04/03/2026. Soon after receiving the information, on the directions of SSP Doda, a special police team from Police Station Doda was constituted led by IC PP Goha Marmat to trace out the missing lady. Acting promptly, Doda Police initiated search efforts. During the course of investigation and sustained efforts by the police team, the said lady was successfully traced out today on 05.03.2026 from the Thandapani area of Assar. After completing all necessary legal formalities, the lady was safely handed over to her legal heirs. Accordingly, the missing report has been closed as per procedure.

5 narco-smugglers nabbed with heroin

SAMBA: Continuing its drive against drug smugglers & peddlers, Samba Police has arrested two drug peddlers in the jurisdiction of Police Station Vijaypur and recovered approximately 10.72 grams heroin-like substance (chitta) from their possession. A Police team of Police Station Vijaypur during vehicle checking naka at NHW AIMS Vijaypur; intercepted a Mahindra Scorpio bearing registration No. JK02AB-0002 for its checking which was coming from Samba side and moving towards Vijaypur side. During checking, approximately 10.72 grams of heroin-like substance (Chitta) was recovered from the possession of two persons travelling in the said vehicle. The drug peddlers identified as Rafiq Ahmed S/o Abdul Ferooz R/o Ragoora district Jammu and Ali S/o Mohd Din R/o Lower Ragoora district Jammu have been arrested. The contraband item along with vehicle has also been seized by the police. A case FIR No. 40/2026 u/s 8/21/22/25 NDPS Act has been registered at PS Vijaypur and investigation started. Jammu Police achieved one more success by recovering 16.71 gms of Heroin (Chita) like substance from two drug peddlers near Puro Bhana Chowk, R S Pura under the jurisdiction of Police Station R S Pura. A Police team of Police Station R S Pura led by SHO R S Pura, Inspector Tribhawan Khajuria under the supervision of supervision of SP Headquarters Jammu & SDPO R S Pura, On 04.03.2026, while performing naka/patrolling duty at about 1300 hours, near Puro Bhana Chowk, R S Pura two persons coming from R.S Pura towards Purobhana, on noticing the police party, attempted to escape from the spot, which raised suspicion. Upon this, the alert police party successfully intercepted the persons and apprehended them. On questioning, the persons disclosed their names as 1. Atul Choudhary S/o Narinder Pal R/o Village Puro Bhana, Tehsil R.S. Pura, 2. Mohd Saleem S/o Pissar Din R/o Village Chak Mohd Yar, Tehsil R.S. Pura. During their personal search, 16.71 grams of heroin-like substance, were recovered from their possession. In this regard, a case FIR No.49/2026 U/S 8/21/22/29 NDPS Act stands registered at Police Station R S Pura, accused persons have been arrested, contraband Seized and further investigation is going on to unearth the nexus and work out forward/backward linkages in the case. A police team of Police Station Rehambal while conducting routine naka checking at Naka Point Phalata, NHW, intercepted one passenger vehicle (Ertiga) bearing Registration No. JK01BA-9466 which was on its way from Jammu towards the Srinagar side. During checking of the vehicle, two passengers travelling in the car disclosed their identities as Burhan Majid S/O Abdul Majid Batt R/O Hanjigund Chadoura, Budgam and Arsalan Bashir S/O Bashir Ahmed Batt R/O Chadoura, Budgam. Upon conducting their personal search, 11.27 grams of heroin (chitta) were recovered from their possession. Accordingly, both the accused were arrested on the spot and FIR No. 42/2026 U/S 8/21/22 NDPS Act has been registered at Police Station Rehambal.

Jammu South Police strikes hard on vehicle theft, arrests notorious interstate gang

JAMMU: Jammu Police South Zone, working tirelessly under Operation AVTAAAR, continues to demonstrate its unwavering commitment to curbing vehicle theft, following last month's recovery of 16 stolen two-wheelers. This recent achievement marks another milestone in the Jammu Police, South Zone's relentless fight against organized vehicle theft crime. In a significant crackdown against organized vehicle theft, PS Gangyal of South Zone has successfully dismantled an inter-state vehicle theft module involved in stealing high-end vehicles, including Mahindra Scorpio and other premium cars, operating across multiple states of India. This operation, conducted under the overarching supervision of SSP Jammu, and the close guidance of SP City South and SDPO City South, Jammu has led to the arrest of a notorious vehicle theft gang and the recovery of multiple stolen vehicles, demonstrating the unwavering vigilance and proactive policing of the South Zone. A dedicated police team was formed, comprising PSI Rahul Kumar; ASI Sanjay Kumar; and Sgdt Manpreet Singh, with investigation and operational activities meticulously monitored by Insp Sanjeev Chib, SHO PS Gangyal. During the investigation, the team conducted multiple raids across North India, employed advanced technical analyses, and scrutinized CCTV footage from various locations. These efforts were pivotal in identifying the accused and tracking the movement of stolen vehicles across state borders. The investigation revealed that the gang operated a highly organized inter-state vehicle theft network. The accused would steal vehicles from different states and sell them across northern regions, systematically altering chassis numbers, changing number plates, and manipulating other identification details to avoid detection. High-end cars, particularly Mahindra Scorpio and other premium vehicles, formed the primary targets of the gang's illicit operations. The main accused has been identified as Pawan Kumar S/o Kamal Singh R/o Viran, Tshsham, District Bhiwani, Haryana, who, along with his associate Ramesh Singh S/o Anchal Singh R/o Deena Nagar near St. Xavier Convent School, Barnai, Jammu, orchestrated this extensive theft network. Pawan Kumar is linked to approximately 70 FIRs related to vehicle theft across multiple states, with preliminary intelligence suggesting the gang may have stolen nearly 1,000 vehicles over the past 7-8 years.
