The applicants/Caveators most respectfully submit as under:-

- That initially, Gokal Brahmin constructed a Mandir Shri Radha Krishan Ji on a land measuring One kanal underlying khasra No. 569 out of his total land measuring 80 Kanals 08 marlas (Eighty Kanals Eight Marlas only) underlying khowat Nos. 11 and 12 situated at Village Chak Dulma, Tehsil Rajpura, District Samba. Since Gokal Brahmin was issueless and religious person, so, he made a Gift of his entire immovable estate in favour of the applicant No. 5 Mandir and appointed the grand-father of the applicants No. 1 to 4 namely Sh. Bihari Lal (now deceased) as a Mohitlim / Manager of the applicant No. 5 Mandir and after the demise of the grandfather of the applicants No. 1 to 4, initially, the father of the applicants No. 1 to 4 namely Sh. Prem Pal(now deceased), and thereafter, the applicants No. 1 to 4 inherited all the rights of the management and control of the applicant No. 5 and its properties as a Mohitlim and are performing their duties as a Mohitlims/Pujaris of the Mandir.
- That some influential persons of the village where the applicant No. 5 Mandir is existing with vested interest, started creating hurdles in the management and affairs of the Mandir, with sole intention to somehow forcibly take possession and control of the big chunk of land attached to the applicant No. 5 Mandir and grab the said land and also usurp its usufructs which constrained the applicant to file Civil Suit before the Court of Learned Principal District Judge, Samba, and the learned Court has already passed the order qua the subject matter of the suit property.
- That the applicants have strong apprehension in their mind that some person with vested motive in order to cause serious prejudice to the rights of the applicants, may like to file plaint or any other proceedings in respect of the aforesaid land of applicant No. 5 before this hon'ble Court by suppressing the facts from this hon'ble Court.
- That in the event of filing of plaint or any other proceedings before this hon'ble Court, the applicants craves the kind indulgence of this hon'ble Court to the effect that passing any ex-parte order in the said plaint or any proceedings, applicants may kindly be heard in the matter.
