DC Kupwara inspects ongoing developmental works in Qadirabad, Trehgam blocks

KUPWARA: The Deputy Commissioner (DC) Kupwara, Inam Din on Saturday visited different areas of block Qadirabad and Trehgam in the district and to take stock of various on-going developmental works, besides, he also heard various public delegations. During the visit, the DC inspected construction of R-Wall and Drain at Dar Mohallah Awoora constructed at a cost of Rs.2 lakh under MPLADS. He also inspected the Panchayat Ghar Awoora and directed the concerned BDO for projecting the Panchayat building for its renovation. Inam Din also heard local people who put forth various demands including upgradation of Dar Mohallah link

road. He directed the concerned officer for assessment of the road through a team of engineers for its augmentation. Later, the DC visited Trehgam block and inspected the renovation work of Tehsil Office building which has been approved at a cost of Rs.9 lakh under Kahcharie rent. He also inspected the construction of R-Wall at Hill Top Trehgam which has been constructed at a cost of Rs.6.8 lakh under Area Development Fund (ADF).

While interacting and listening to various public delegations during the entire visit, the DC said that the Government has strengthened the roots of Panchayati Raj system and people should take maximum benefit from it.
