





Subsequently family of girl was informed and she was handed over to them after completing all legal formalities.

Man held for illicit distillation, approx 15 lts liquor seized

JAMMU: Police on Tuesday nabbed five bootleggers in separate actions and recovered 163 bottles of illicit liquor from their possession. As per details, information was received through reliable sources regarding sale of illicit liquor in Domana area. On this, a police team under supervision of SDPO Domana Sunil Singh led by SHO Domana Insp Mahesh Sharma during Naka checking at Patta Bohri chowk, rounded up a suspect. During search, 40 bottles, including 36 bottles of 250 ml and 4 bottles of 180 ml were recovered from his possession. The accused identified as Raghveer Kumar, son of Janto Ram, resident of Dei Chak, Gho Manshan was arrested and FIR No. 130/2022 under section 48-a of Excise Act was registered against him at Police Station Domana. The overall operation was done under the supervision of SP Rural Sanjay Sharma.

Meanwhile, Akhnoor police also arrested three bootleggers namely Amarnath, son of Kaka Ram, resident of Mishriwala along with 24 bottles of illicit liquor; Suram Chand, son of Sain Dass, resident of Narsingh Pura Pargwal along with 15 bottles and Pawan Sharma, son of Om Parkash, resident of Khour Camp along with 10 bottles of illicit liquor. FIR Nos. 93, 94 & 95/2022 under sections 48 (A), (F) of Excise Act were registered against them at Police Station Akhnoor. The arrests were made by party of Police Station Akhnoor under SHO Hiral Azhar.

In another incident, a party from Police Station Udhampur led by SHO Udhampur Insp Chaman Gorkha and under supervision of Addl SP Udhampur Anwaar Ul Haq and DySP Hqrs Udhampur Sahil Mahajan, apprehended two suspects. On frisking, 74 quarters (250 ml each) of Desi Special Whisky were recovered from their possession. The bootleggers, identified as Kaka Ram, son of Ram Chand, resident of Bhisht, Chenani and Kuldeep, son of Tara Chand, resident of Gouri Kund, Chenani, were arrested and FIR No. 153/2022 under section 48(F) of Excise Act was registered against them at Police Station Udhampur.

9 bovines rescued, vehicle seized

SAMBAL: Police on Tuesday foiled an attempt to smuggle bovines by rescuing 9 bovines and seized a vehicle.

As per details, acting on an information received from reliable sources regarding illegal transportation of bovines, a party from Police Post Mansar during vehicle checking duty at Naka point Mansar signaled a Dumper (HR68A/ 4001) to stop but driver accelerated the speed and jumped the Naka. Afterwards, he fled away leaving vehicle abandoned at few meters away from Naka point when chased by Police. During checking of vehicle, 9 bovines were found laden inside it which were rescued. In this connection, FIR No. 83/2022 under sections 188/279 of IPC, 11 of PCA Act was registered in Police Station Samba.

KATHUA: An unidentified youth snatched cash amount of Rs 50,000 from a woman at Haldi Morh, Kathua on Tuesday.


