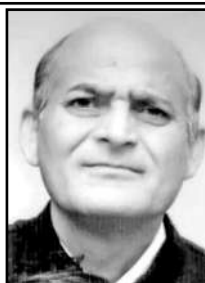

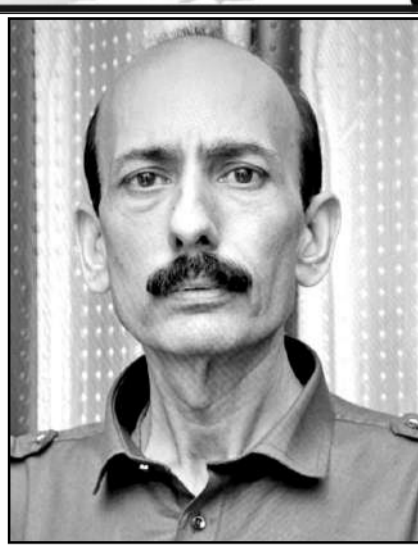

**DC Kathua condoles death of Tribal woman in road accident; sanctions Rs 1 Lakh relief to bereaved family**

KATHUA: Deputy Commissioner Kathua Rahul Yadav on Thursday expressed anguish over the tragic death of a tribal woman in a Bus-Cart accident at Londi Morh, Hiranagar. The accident happened when a convoy of Tribal was hit by a speedy bus in which a lady member of the tribal group lost her life and few others were injured.
