JAMMU: In a meeting held here on Saturday, the members of General Category People's Front (GCPF), under the leadership of their Chairman Raj Kumar Banthia, deliberated upon the socio-economic and political policies of government.

While speaking during the meeting, Prof Yash Paul Sanson, President alleged that General Category people (Swarn Castes) have been facing persistent neglect and deprivation due to continuation of caste-based discrimination and restricting application of basic fundamental rights of majority. Sanitation workers hold protest, many detained

JAMMU: Several sanitation workers were detained on Saturday after they staged a protest against the Jammu Municipal Corporation (JMC) in support of their demands including regularisation of their service here, officials said. The workers, including women, gathered under the banner of Civil Safai Karamchari Union near Press Club in the heart of the city and tried to march towards the main road when police initiated the action, the officials said.

They said over 12 workers, including their leader Rinku Gill, were whisked away in police vehicles to the nearby police station, where they were briefly detained.



"We were assured of the fulfilment of our long pending demands within one month after our last meeting with the government at civil secretariat on February 28. The government is only making false promises but we are determined in our struggle for our genuine demands," Gill said.

The union is demanding regularisation of the services of those workers who have completed seven to 13 years and better work atmosphere and safety equipment.

"We are setting a deadline of 72 hours for the fulfilment of our genuine demands, otherwise we will intensify our struggle from Monday," Gill said.

Injunction or interference in tender leads to additional costs on State: DB

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court comprising Chief Justice Pankaj Mital and Justice Mokshu Khajuria Kazmi while dismissing appeal of one Rakesh Kumar challenging decision dated 6th December 2021, taken by respondents 1 to 3 whereby petitioner has been technically disqualified in reference to Request for Proposal (RFP)-Tender e-Bid No.2021-AAI-82001-1 issued on 13.07.2021 for concession to design, fit-out, finance, develop, market, operate, maintain and manage the food and beverage outlets at Civil Airport, Jammu, after hearing senior Adv Sunil Sethi with Adv Navyug Sethi for

appellant whereas Advocate Inderjeet Gupta with Adv Yatin Mahajan for Airport Authority of India, observed that Court does not have the expertise to examine terms and conditions of the present day economic activities and this limitation should be kept in view. "Courts should be even more reluctant in interfering with contracts involving technical issues as there is a requirement of the necessary expertise to adjudicate upon such issues. The approach of Court should be not to find fault with magnifying glass in its hands, rather the Court should examine as to whether the decision-making process is after complying with the procedure contemplated by the

injunction or interference in the tender leads to additional costs on the State and is also against public interest. Therefore, the State and its citizens suffer twice, firstly by paying escalation costs and secondly, by being deprived of the infrastructure for which the present-day Governments are expected to work," the Court observed.

DB further observed that the submission of counsel for the petitioner-appellant is that previous to the petitioner, the restaurant of the petitioner - M/s Airport Restaurant, of which the petitioner is the proprietor, was being run by his mother and before her by his father as a sole proprietorship firm. "Experience or the turnover of the said restaurant during the period it was being run by his mother and father is also supposed to be taken into consideration. The aforesaid restaurant of the petitioner is being run in the sole proprietorship and not by any separate legal entity. The sole proprietorship has the entity of the proprietor only. The firm is only the trade name but the business is owned by the proprietor. In the instant case, the petitioner is bidder and, therefore, his business experience/turnover has to be considered for purposes of his eligibility rather than the business which was carried by his mother or father," the Court observed and upheld the judgment of Single Judge, dismissing appeal filed by the appellant.
