

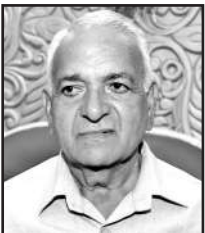

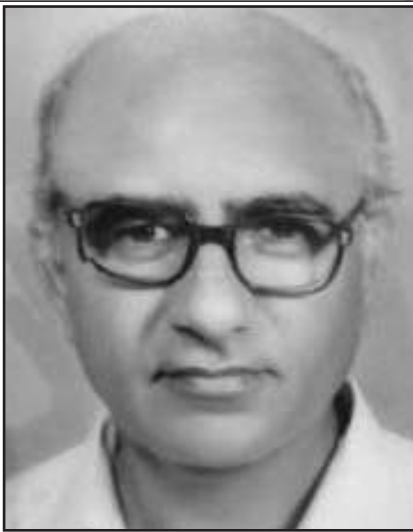
SHRADHANJALI

CRIME REPORT

Two held for illicit distillation; approx 20 lts liquor seized

KATHUA: Taking stringent action against consumption/production of illegal liquor menace, Kathua Police under the overall supervision of SSP R C Kotwal on Sunday seized approximately 20 lts of illicit liquor and arrested 2 persons near Muthi Jagir and Mirpur Jagoo.

As per details, on April 16, 2022 information was received from reliable sources that illicit liquor was being manufactured in Muthi Jagir and Mirpur Jagoo along with other adjoining areas. Acting swiftly, police team led by Insp Balram Sharma Incharge Police Post Nagri under the supervision of DySP Headquarters Kathua Shammi Kumar during special checking/ patrolling duty noticed a suspect. On checking, approximately 10 lts of illicit liquor was recovered from possession of suspect, later identified as Verna, son of Waryam Singh, resident of Muthi Jagir Tehsil Nagri.

In another instance another police team of Police Post Nagri led by PSI Riaz Ahmed during special checking duty at Mirpur Jagoo intercepted another suspect. During checking, 10 lts of illicit liquor was recovered from his possession. The accused, identified as Chanda Ram, son of Kartar Chand, resident of Mirpur Jagoo Tehsil Nagri, was arrested and FIR No. 145 & 146/2022 under section 48(A) of Excise Act was registered at Police Station Kathua.

Kidnapped minor girl recovered; accused arrested

KATHUA: In its efforts to minimize crime, Kathua Police under the overall supervision of SSP R C Kotwal on Sunday recovered a kidnapped minor girl and arrested an accused.



As per details, on April 17, 2022, a team led by SHO Police Station Malhar Insp Tariq Ahmed under the supervision of SDPO Billawar Arvind Kumar managed to recover a kidnapped minor girl, resident of Tehsil Billawar and arrested accused namely Makhan Din, son of Hussain, resident of Godu Flail Tehsil Lohai Malhar from Lakhampur for which FIR No.07/2022 under section 363 of IPC was registered at Police Station Malhar. The minor girl was immediately handed over to her legal heirs after completing all legal formalities and further investigation is going on.

Theft case solved; 2 arrested, stolen items recovered

JAMMU: Police on Sunday solved a theft case by arresting two accused persons and recovered stolen items.

As per details, a complaint was lodged at Police Station Gharota by one Kunal Dogra, son of Dewan Chand, resident of Janipur Colony stating that some thieves stole some items from CSC centre at Panchayat Ghar Kot. On this, FIR No 34/2022 was registered and investigation started. After this, a team of Police Station Gharota under supervision of SDPO Akhnor Varun Jandial led by SHO Gharota Insp Rajesh Khajuria, after putting in strenuous efforts and with the help of CCTV footages of area, rounded up two suspects namely Naresh Kumar, son of Brij Lal, resident of Nardani, Raipur and Avinash Kumar, son of Vakil Chand, resident of Kot, Bhalwal. During questioning, both accused confessed their involvement in crime and on their disclosure stolen items were recovered from their possession.

Three drug peddlers arrested; 14 Kg Ganja, Rs 1.52 lakh cash recovered

JAMMU: Police on Sunday arrested three drug peddlers and recovered 14 Kg Ganja and Rs 1.52 lakh cash from their possession.

As per details, a team of Police Station Bahu Fort constituted under the supervision of SDPO East Syed Zaheer Abbas Jafari, led by SHO Bahu Fort Insp Nayat Ali assisted by PSI Balbir Singh while on Naka duty rounded up a suspect. On search, 12 Kg Ganja was recovered from his possession. The accused was arrested and FIR 109/2022 under sections 8/20 of NDPS Act was registered against him in Police Station Bahu Fort. The accused was identified as Tirith Ram Sahu, son of Net Ram Sahu, resident of Parsada, District Janjgir Champa Chhattisgarh.

Similarly, two more suspects, identified as Vicky, son of Rotas, resident of Rajasthan Churru, at present Rajeev Nagar, Narwal and Deepak Kumar, son of Sanjay Kumar, resident of Delhi Rohini sector 4, at present Rajeev Nagar were rounded up near Rajeev Nagar Naka by a team of Police Post Narwal led by SHO Bahu Fort Insp Nayat Ali assisted by Incharge Police Post Narwal SI Achal Rana.

During search, 2 Kg Ganga and Rs 1.52 lakh cash were recovered from their possession.

Duo was arrested and FIR No 110/2022 under FIR under sections 8/20/29 of NDPS Act was registered against them at Police Station Bahu Fort. The whole operation was done under supervision of SP South Mamta Sharma.

PDD lineman dies of electric shock

BUDGAM: A PDD lineman died after receiving an electric shock in Hafroo area of Budgam district on Sunday.

As per details, a lineman identified as Mohammad Ashraf Mir, resident of Badapora Nagam Chara-e-shrief received electric shock while repairing a transformer in Hafroo area. Soon after receiving electric shock, Ashraf Mir was shifted to a local hospital, however, doctors declared him brought dead on arrival. Cognizance of the incident has been taken by police and further investigation is going on.

Minor raped, 50-yr old accused arrested

JAMMU: Police on Sunday arrested a 50-year old man for raping a minor girl in Janipur area.

As per details, parents of victim lodged a complaint with Janipur Police that their neighbor, who is about 50 years old, took their daughter to his house and raped her. Acting on complaint, police conducted medical examination of girl and later arrested the accused.

Man attacked over dispute, car damaged

JAMMU: A man was attacked over a dispute on Sunday and his car was also damaged by attackers.

As per details, one Pawan Mahajan, resident of Trikuta Nagar lodged a complaint with Kana Chak police that he was attacked by one Naresh Kumar alias Neshu, when he was on way to home with his workers from his brick kiln. He further alleged that accused also damaged his car by hitting it with sharp-edged weapon. Police has registered a case and started investigation.

9 bovines rescued, 2 vehicles seized

RAJOURI: Police on Sunday rescued 9 animals from clutches of smugglers in Rajouri area and seized two vehicles.

As per details, a team of Rajouri police led by SHO Fared Choudhary under the supervision of DySP HQ Rajouri Vinod Sharma during Naka checking intercepted a Tata mobile and another vehicle, laden with nine bovine animals, which were rescued.

FIRs 161 & 162/2022, under section 188 IPC, 11 PCA Act were registered in this regard and vehicles bearing registration numbers JK11B 9204 and JK11E0551 were also seized by Police.
