Junaid for his well-composed innings of 65 runs in the chase earned him a man of the match award. The second match of the day between Mattipora Sports Club and Star Sports Mattan was in progress when reports last came in. Meantime, the last match in the qualifying round of JKSC Youth Football League-2022 being

played at Gani Memorial Stadium, Srinagar was played between SCFA Bandipora and Sopore FA yesterday was won by the former by a margin of 3-1, registering their entry into the final round.

The encounter was crucial for both the teams and it was a must-win situation for both the teams to stay alive in the league. Though Sopore FA drew first blood in the first half but could not maintain the lead as Bandipora scored back to back 3 goals in the second half. With this win, Bandipora earned 6 points

and entry to the final round of the league, thus becoming the fourth team to do so. Zahir of Bandipora was adjudged player of the match for scoring a stunner and assisting one in the pursuit to win an all-important game for the team.

## Ex-CPFWA urges Union Govt to fulfill demands

JAMMU: Ex-Central Paramilitary Forces Welfare Association (CPFWA) has demanded separate Armed Forces Service and Pension rules for Paramilitary Forces instead of CCS Rules and urged the Government to fulfill all pending demands at the earliest. In a meeting of the association, held in Nowshera, Shashi Kumar Sharma, Association President demanded that Paramilitary Forces being Armed Forces should be exempted from New Pension Scheme (NPS). "Ex-Central Paramilitary Forces Welfare Association demands separate Armed Forces Service and Pension Rules for Paramilitary Forces instead of CCS Rules," said Sharma, urging Union Home Ministry to consider their demands which also include One-Rank One Pension and CSD canteen facilities instead of Central Police Canteen at State/District level. "Paramilitary forces face enemy and made sacrifices with same

vigour, valour and patriotism and suffer consequences just like defence forces. But benefits and concessions extended to Armed forces are not being extended to them which is against the law and ethics of

natural justice," he asserted, and urged Union Home Ministry to consider all their pending demands at the earliest.

Committee appointed Mohan Lal Chibber as new president of Nowshera and Sunderbani sector. Harbans Lal Vice President J&K (UT) was also present in the meeting.
