PUBLIC NOTICE

As per the guidelines of Animal Welfare Board of India and for Implementation of Prevention of Cruelty to Animals (Dog Breeding and Marketing) Rules, 2017 & Prevention of Cruelty to Animals (Pet Shops) Rules, 2017 framed under PCA, Act, 1960, -Provisional Registration of Pet Shops/ Dog Breeder Establishments, every Pet Shop Owners and Dog Breeders needs mandatory registration with the Animal Husbandry Department till the establishment of Animal welfare Board of Union Territory of J&K.

Pet Shop Owners and Dog Breeders/ Dog Sellers/dog kennels working in district Udhampur are once again advised to get themselves provisionally register with the Animal Husbandry Department District Udhampur Within one month from the date of publishing of this Public Notice in the newspapers. The Pet Shops/Breeding Centers/Dog Sellers should adhere the guidelines issued by the Animal Welfare Board of India for "Implementation of Prevention of Cruelty to Animals (Dog Breeding and Marketing) Rules, 2017 & Prevention of Cruelty to Animals (Pet Shops) Rules, 2017 framed under PCA, Act, 1960-Provisional Registration of Pet Shops/ Dog Breeder Establishments". Pet Shops/Dog Breeders/ Dog sellers running their business in any way without registration and illegally in District Udhampur will not be allowed to work and are advised to follow the guidelines and get registered themselves or close the illegal business of money making and prevent cruelty to Animals otherwise strict legal action as per rules will be taken against all the illegal Pet Shops/Dog Breeding Centres /Dog sellers.
