Subject:- Use of High Security Registration Plates (HSRP) made mandatory in all motor vehicles.

PUBLIC NOTICE

The General Public/owners of the motor vehicles are hereby informed through the medium of this notice that the J&K Motor Vehicles Department in compliance with the directions of the Hon'ble Supreme Court has made affixation of HSRP plate mandatory vide circular No. TC-JK/P/S/597-99 dated 01-02-2016. The Motor Vehicle Owners were, therefore required to affix the same in their respective vehicles by or before 16th September, 2017. Time and again public notices in this regard have been given by the Traffic Police Department / Motor Vehicles Department for affixation of the HSRP. However, it has observed that number of motor vehicles are still plying on road without affixing mandatory HSRP and is therefore violating orders of the Hon'ble Supreme Court / Department.

Accordingly, a final notice is given to the owners of all motor vehicles to ensure affixation of HSRP in their motor vehicles from the authorized vendors by or before 15th of May, 2022. Any default in this regard shall be treated as wilful violation by the concerned motor vehicle owner and may lead to the seizure and black listing of the defaulting vehicle.
