They have already appealed to the District Development Council (DDC) Chairperson, Vice Chairperson and Deputy Commissioner Reasi.

After hearing the demand of the villagers, district administration wrote a letter to Divisional Commissioner Jammu and Chief Electoral Officer Jammu & Kashmir to readdress the demand of the villagers.

Sharing his views, Bodh Raj Sarpanch of Village Kundra and Bhabbar said that the village Kundra and Bhabbar are very near to district administration Reasi and it is approachable for every folk living out here.

We have received information that our villages

are to be attached with some other constituency which is unacceptable for us.

We have also written a letter to the District Development Council regarding the same issue. Last year the Union Government made a change in which our villages were attached with the Katra block and we want our villages to be attached with Reasi as soon as possible.

Another localite, Kali Dass shared that if our villages Kundra, Bhabbar Brahmana and Dera get attached with some other constituency, we will agitate and come on roads as we strongly oppose this move and request administration to keep us with Reasi constituency.

He further added that we should raise our voices in front of delimitation commission members who came all the way to Jammu and Kashmir to meet leaders of Jammu and Kashmir.

By Controller Consumer Protection, Jammu enlightened the students how to become an aware consumers by taking little extra precautions while making purchases and just because of ignorance one can fall prey to cheating thereby losing their hard earned money.



He stressed on participants to exert their duties like checking of Zero before fueling petrol at dispensing pumps, taking of bills/ stamped warranty cards and preserving them, making complaints as and when being cheated and taking refilled LPG cylinders by weighing at the time of home delivery for which practical demonstration was given to students.

The chairman of the School, Prabha Jain also shared with students her experience of filing of complaints in Consumer Courts against unfair trade practices and deficiencies in services and getting remedies.

Principal of school also spoke on the occasion and committed to form consumer club of students so as to interact with other students on regular basis about spreading of awareness.
