Narco smugglers attack cops; 1 nabbed with heroin, Tokas, cash over Rs 7.3 lakh, 3 flee

RAMBAN: Four narco-smugglers attacked a police party during checking, however one of them was arrested and heroin, sharp-edged weapons and cash over Rs 7.3 lakh was recovered from his possession.

As per details, acting on specific input of narcotic smuggling, a team of Police Station Chanderkote headed by SHO Inspector Padam Dev Singh while Naka checking, signaled a Baleno car (JK02-CE-1860) to stop for checking but driver of vehicle, with criminal intention, broke Naka point by hitting and damaging barriers besides committing a murderous assault on police party. The vehicle was chased by police party and stopped at Kumfer, Chanderkot. All the four persons in car including driver came out with Tokas and again carried out a murderous assault on police party but alert cops, acting swiftly, arrested one assaulter namely Mam Hussain, son of Dauwa, resident of Laswara, Bishnah, along with a Toka while three other persons, taking advantage of darkness, fled away. The arrested accused disclosed names of driver and two others as Bashir Ahmed, son of Noor Ahmed, resident of Langotia; Barkat Ali, son of Hussain Ali, resident of Jodha, Tehsil R S Pura and Bagh Ali, son of Rehmu, resident of R S Pura, Jammu. On search of vehicle, two more tokas along with cash amounting to Rs 7,39,000 was recovered. FIR No. 79/2022 under sections 307/427/34 of IPC, 4/25 of Arms Act was registered in Police Station Chanderkote. During sustained interrogation of accused, it came to fore that accused has thrown black-coloured polythene containing Chitta (Heroine) below culvert at Kumfer and on his disclosure, 12 gm Chitta (Heroine) was recovered. As such, offences under sections 8/21/22/29 of NDPS Act were also added in instant case. The case is under investigation and search for other accused persons is going on. The overall operation was carried out by police party headed by Insp Padam Dev Singh under supervision of Pardeep Singh Sen DySP Hqrs Ramban with overall supervision of SSP Ramban, Mohita Sharma.

8 bovines rescued, smuggler arrested

RAJOURI: Police has foiled a bovine smuggling bid by rescuing eight animals and seizing the vehicle used in crime besides arresting accused driver.

As per details, in wee hours on Thursday, a team of police headed by Incharge Police Post Chingus Chatyar; PSI Sahil Chowdhary was on regular patrolling and intercepted a Tata mobile vehicle. The vehicle with registration number JK11E 2441 was being driven by one Mohd Gafoor, son of Mohd Bashir, resident of Bhattian Thannamandi and found laden with eight bovines, which were rescued and driver was arrested.

In this connection, cognizance has been taken under relevant sections of law and investigation is going on.
